Protecting the Majority of Humanity: Toward an Integrated Approach to Crimes against Present and Future Generations

Until recently, human rights theory and action has focused primarily on the so-called public sphere from which the majority of humanity – women and children – were traditionally barred. However, if we are serious about a more just, peaceful, and sustainable future, we have to recognize that our first, and most lasting, lessons about human relations are learned not in the public but in the private sphere. This is where people learn to respect the rights of others – or where they learn to view human rights violations as normal...

An effective approach to protecting the human rights of present and future generations must include the private sphere of family and other intimate relations. This is essential not only because widespread, chronic, and abhorrent, violations of the human rights of women and of children are a global pandemic, but also because psychology and neuroscience show that what children observe and/or experience in family affects their adult beliefs, behaviors, political attitudes – even the neural structures of their developing brains.

Exposing Family Court Corruption

NO WAY OUT BUT ONE by Garland Waller and Barry Nolan

In 1994 Holly Collins became an international fugitive when she grabbed her three children and went on the run. It all happened because a family court had ignored Holly's charges, the children's pleas, Holly's broken nose, Zackary's fractured skull, and other medical evidence of domestic violence. The family court in Minnesota gave full custody of Zackary and Jennifer to Holly's ex-husband. It was at that point that Holly came to believe she and the children had No Way Out But One.

In what has become an incredible saga, Holly eventually fled the United States. For awhile, she lived beneath the radar, hiding on Indian Reservations, in Mexico and Guatemala. With three children and no passports, incredibly, she made it to Amsterdam where she blurted out a plea for asylum. The fact that she was fleeing domestic violence and would not be protected if she were returned to the US seemed ridiculous at first. But Holly had come armed with documents – legal and medical. At first, she and her children were treated as refugees, living in a refugee center with other poor souls fleeing violence torn hell-holes from around the world. Living shoulder to shoulder with people learning to use indoor plumbing for the first time in their lives, Holly and her kids made the best of it. At least they were safe.

Holly became the first U. S. citizen to be granted asylum by the government of Netherlands. She lived a quiet, low profile life for the next 14 years, until the FBI agents came calling. Hoping to return Holly to the United States to face kidnapping charges, they interviewed her now grown children. Jennifer and Zackary told the agents that far from being their kidnapper, their mother was their savior and their hero.

Eventually, all charges against Holly were dropped, save one: contempt of court. Holly readily acknowledged that after all she and the children had been through, she did indeed harbor "contempt of court." In September of 2011, Holly and her children returned to North America.

SMALL JUSTICE: LITTLE JUSTICE IN AMERICA'S COURTS by Garland Waller

Fathers who battered the mother are twice as likely to seek sole custody of their children as are non-violent fathers. Amer. Psychological Assoc.

This program explores the family court system which routinely takes children away from the protective parent and puts them in the care of the person the children have named as their abuser. It describes how fathers use and sacrifice their children in order to control and punish the mothers, and how the courts, often unwittingly, help those men. By following the stories of three dedicated women and their lawyers the program exposes a systematic legal failure to protect those who need protection the most.

Review by Geral Peary (October, 2001) - *There are dreadful things going on behind the closed doors of American family courts, according to local filmmaker, Garland Waller, in her engrossing and deeply disturbing documentary, Small Justice. Waller paints a horrific picture of injustice prevailing: in 70% of custody cases in the USA in which a husband is accused of sexually abusing his children, he's the one who ends up with them in his care. A typical scenario: a battered, estranged, sleep-deprived wife who, understandably seems in disarray and shock, begs a judge to take children away from her husband who has been sexually molesting them. The husband, a practiced, psychopathic liar, appears smooth in court and denies any wrongdoing. The judge, put off by the wife and impressed that the husband has come to speak up for the kids, gives them over to dad. As for her charges of sexual abuse: that's proof that mom has lost her bearings and can't raise her kids. Moving from the abstract to real stories, filmmaker Waller follows three courageous moms as they battle through courts to get back their children. This is an important movie: Congress should take a look at it!*

DEBATING RICHARD GARDNER by Garland Waller

This new program from Garland Waller, the producer of the award-winning *Small Justice: Little Justice in America's Family Courts*, is designed to stimulate discussion and to help experts understand the controversy surrounding "Parental Alienation Syndrome," a theory invented by Dr. Richard Gardner that is misleading at best, and dangerous and damaging at worst.

The video features an interview with Dr. Gardner, completed a few years before he committed suicide and clips from a television interview program, featuring Waller and Dr. Joy Silberg of The Leadership Council. Cutting back a forth between Gardner and the studio, viewers can see for themselves that Gardner's arguments are not only flawed, but extremely harmful to children and the protective parent, whether mother or father, who has raised the issue of possible sexual abuse.

Small Justice helped to raise awareness of alarming injustices in the family courts that seem ill prepared to handle matters that touch on criminal sexual conduct. This new program will add an important dimension to this on-going problem and hopefully lead to helpful solutions.

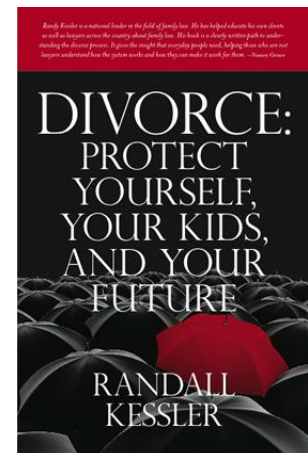

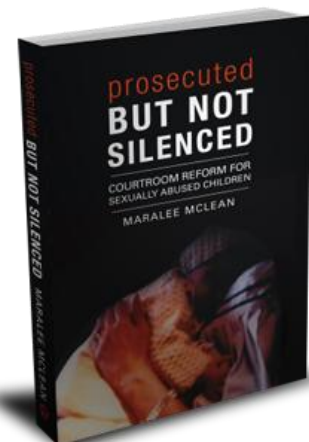

It will help those moms in the middle of the battle to gain insight and to educate your own attorney and other professionals in the system.

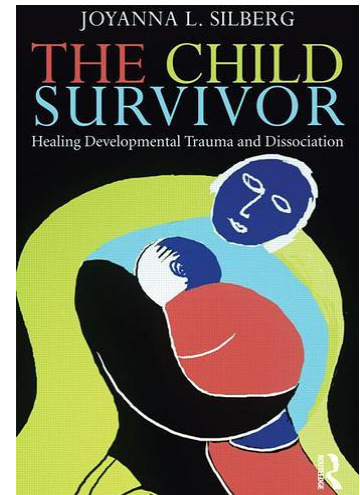

THE CHILD SURVIVOR: HEALING DEVELOPMENTAL TRAUMA AND DISSOCIATION by Joyanna Silberg, Ph.D.

Chapter 14: *The Child Survivor: Healing Developmental Trauma and Dissociation* In a recent court case in which I was an expert witness, a mother was accused of “alienation” because her three-year-old child used the word “Daddy” for the man who raised him. When the boy was two, his biological father suddenly appeared on the scene. Because the child did not switch over to calling his biological father “Daddy” immediately, the mother was considered to be guilty of alienation. Courts need to understand why conclusions like this ignore children's developmental realities, and practitioners need to educate courts rather than buying into the court’s flawed reasoning.



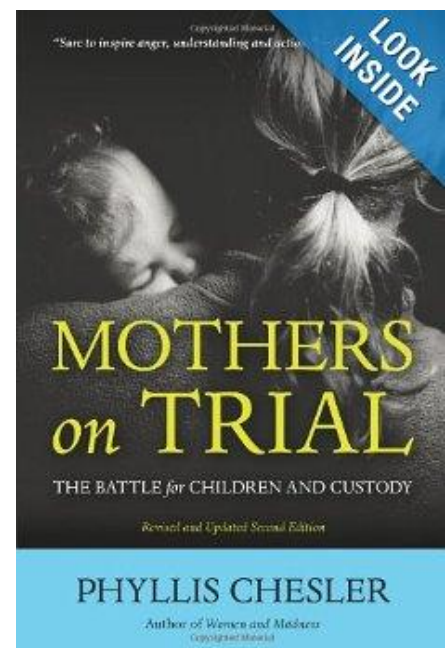
It’s profoundly disrespectful to children to ignore their perceptions about the reasons for difficulties in a relationship and to assume it is the fault of a third-party, as is the case with parental alienation theory.

The Child Survivor is a clinically rich, comprehensive overview of the treatment of children and adolescents who have developed dissociative symptoms in response to ongoing developmental trauma. Joyanna Silberg, a widely respected authority in the field, uses case examples to illustrate hard-to-manage clinical dilemmas such as children presenting with rage reactions, amnesia, and dissociative shut-down. These behaviors are often survival strategies, and in *The Child Survivor* practitioners will find practical management tools that are backed up by recent scientific advances in neurobiology. Clinicians on the front lines of treatment will come away from the book with an arsenal of therapeutic techniques that they can put into practice right away, limiting the need for restrictive hospitalizations or out-of-home placements for their young clients.

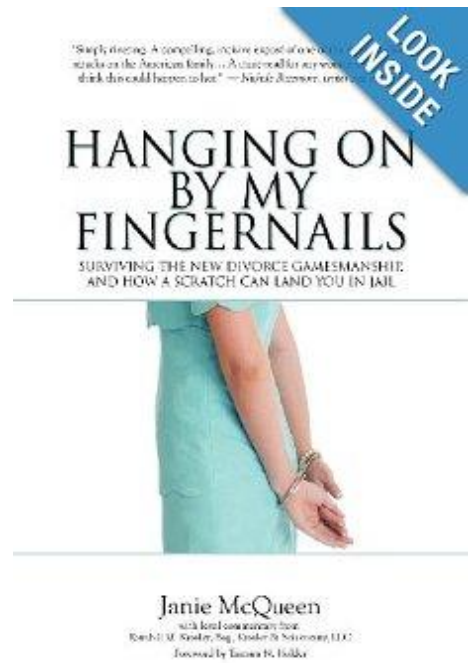

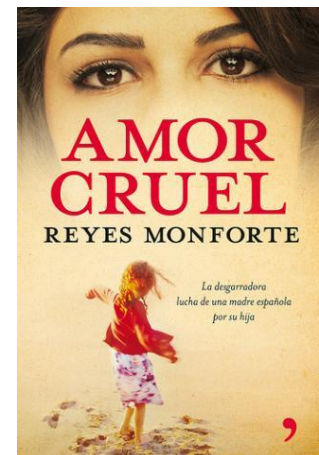
AMOR CRUEL [CRUEL LOVE] by Reyes Monforte

Cruel Love is about the incredible case of a woman from Valencia, Maria Jose Carrascosa, incarcerated since 2006 in a prison in New Jersey for not having renounced the custody of her daughter. The story starts in 1998 when she, in love and with many illusions, married an American that she had known a short time before. But, it was soon after that the prestigious lawyer started to suspect the evasive and mysterious attitude of her husband. When they had already had a daughter she started to discover the lies hid beneath their tranquil life, it was too late: "Spanish idiot, you now belong to me," murmured Peter Innes, who became the object of her nightmares from that day forth.

Little by little, Maria José discovered the truth about her husband: he had a past prison record for drugs, he had used three different false identities to escape from different charges against him, and he had poisoned her with pesticide and pharmaceutical drugs during their marriage, as he had done with three former intimate partners.

Even so, the Spanish woman was arrested in the USA for having taken her daughter out of the country, and is now facing a prison sentence of 40-70 years. (*At present she is serving a prison sentence of 14 years.*)

Intense, moving and sentimental, *Cruel Love* is a novel that explains a sentiment so strong that a woman would confront the most powerful country in the world: the love of a mother for her daughter.

CHILD CUSTODY JUSTICE by Lundy Bancroft

This introduction is adapted from a section that I wrote for Disorder in the Courts: Mothers and Their Allies Take on the Family Court System, an e-book available from California NOW.

There is no love deeper, more complete, and more vulnerable than the love that caring parents feel for their children. There is a bond so strong that it can be hard to tell exactly where the parent ends and the child begins, and the line is even harder to draw when our children are very young. Mothers have an additional bond from having carried their children inside of their bodies and having given birth to them, and more than half of mothers have experienced a deepened attachment through breast-feeding their babies. And mothers are, in the great majority of cases, their children's primary caretakers, especially during their early years. All connections between caring, non-abusive parents and their children are so important as to be almost sacred, but there is usually a particular quality to the mother-child bond. That life-giving and sustaining connection deserves the full support and admiration of communities and nations....

MYTHS THAT PLACE CHILDREN AT RISK DURING CUSTODY DISPUTES

The Leadership Council on Child Abuse & Interpersonal Violence is a nonprofit scientific organization concerned about the welfare of children. We have become increasingly concerned about the legal system's treatment of victims of family violence during divorce proceedings and child custody disputes. In preparing this paper, we have reviewed documentation from a number of cases in which children were placed in the sole custody of a parent that the children allege abused them. These children were often prohibited from any contact or provided only limited contact with the parent seeking to protect the child, despite the fact that this parent had never been found to have harmed the child. In many cases the child's allegations are quite credible.

We have also reviewed the emerging body of research showing that children who allege abuse are at great risk of not being protected when there is a custody dispute between the parents. Many of these children are victims of incest. There appears to be a need for scientific information to educate professionals about the risks children face during divorce and custody actions. The child's need for protection- which is supposed to be paramount - is lost in the fray.

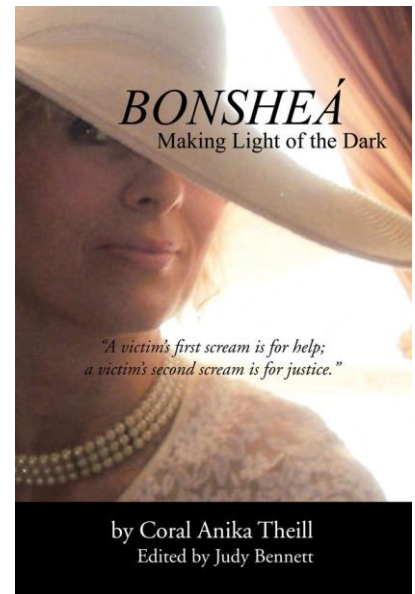

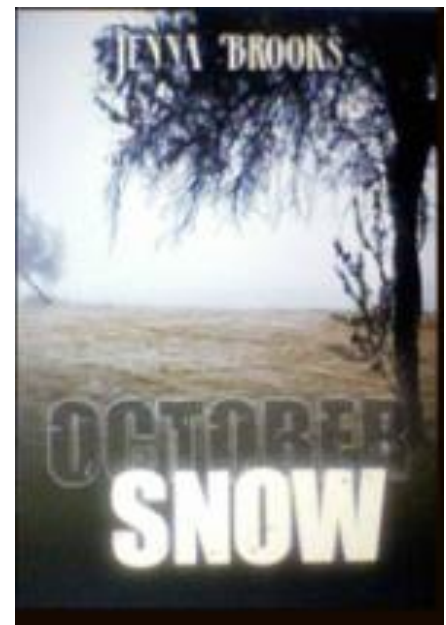

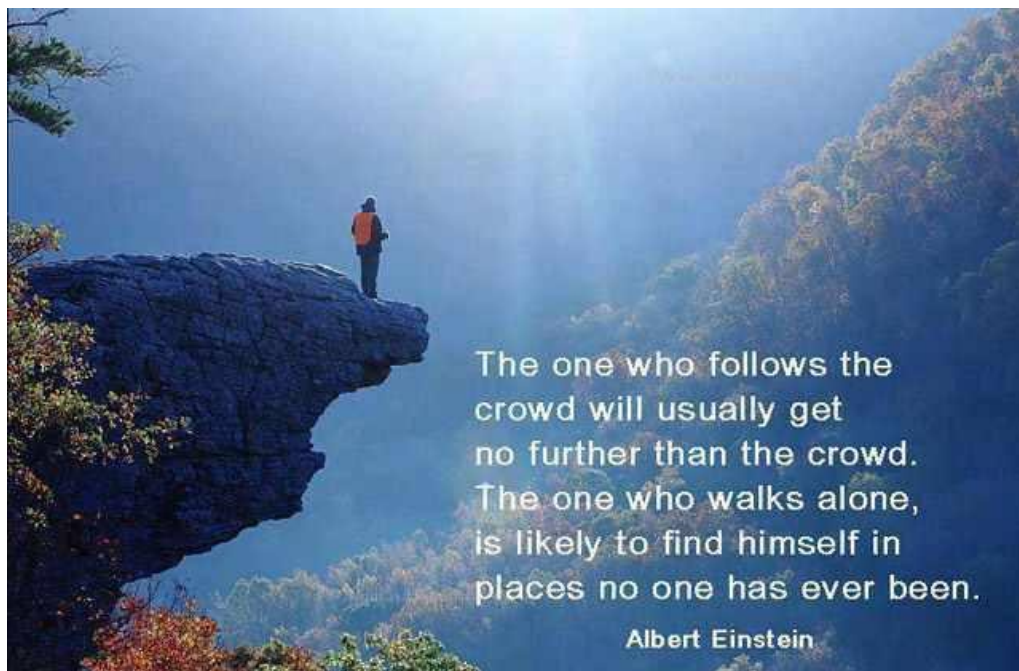
