Dear Hali,

I am contacting you in the interest of Diligence and Transparency and due to the fact that you handle ‘women’s issues’ in ICD. Please find attached my most recent correspondence to ‘public authorities’; this time to [Prince Charles](#), (as well as your colleague, Mark Lewis, Director of ICD’s Global Partnership division (ICDGP)). In my report to Prince Charles, “State of the Union during the Demise of Democracy,” I explain how not only the IMF (and World Bank and UN) are the motor behind increasingly unstable economies (and societies), but also how they are responsible for the escalation of extremism, violence, terrorism, and break down in the rule of law in countries around the world, by their omission of action. Not only is this in direct contradiction to their mandates, but it is costing taxpayers \$9 billion usd each year (operating expense of IMF, World Bank, and UN), on top of another \$1+ billion going to their ‘partners in crime’, NGOs and think tanks in ‘The Swamp’; with corporate taxpayers and shareholders footing the bill for their empty rhetoric. **Instead of preventing another World War and demise of the planet, these organizations are assuring our demise, and descent into Purgatory by their omission of action, and failure to implement.**

Donald Trump won his bid for presidency with a promise to “drain the Swamp,” due to the fact that ‘The Swamp’ desperately needs draining. But, it needs draining of all of the ‘seat-warmers’ and ‘ivory-tower experts’ in the State Department, White House, Department of Justice, US Congress, World Bank and UN (particularly UN Women) to whom I have been writing for the past decade. This is on top of the ‘seat-warmers’ and ‘ivory-tower experts’ I have been rubbing shoulders with in the IMF for the past decade, observing their ‘game-playing’ with as much disgust as I have had for their contemporaries in the corporate and diplomatic corps on both sides of the Atlantic for over 40 years. Extremism, violence, racism, misogyny, discrimination, and break-down in the rule of law is on the rise because of rampant ignorance, stupidity, and corruption amongst these civil servants, coupled with a total lack of governance, transparency and accountability by their managers. This is why ICD’s \$330 million ‘training and technical assistance’ (on top of the \$1 billion operating cost of the IMF) are a total waste of taxpayer’s money.

One cannot ‘train’ incompetent, stupid, amoral and/or lazy people to be diligence, honorable, honest, or to act with dignity and integrity. These are traits that are learned from birth by one’s care-givers, or on rare occasions innate within a person regardless of the environment in which they grow-up. The damage alpha-dominance feminists, who denigrate and belittle the valuable work mothers (and wives), make to society, and the general welfare, is CRIMINAL! And, **their insistence that any woman who does not participate in ‘The Game’, but instead opts-out to care for their families, and raise their children, should be marginalized and ostracized if, and when, they wish to return to the work-force is discriminatory, oppressive, and rendering women more slaves to society than they have been in the past.** At least under previous religious norms restricting women participation in remunerated workforce and society, they were afforded some rights and protection under the law. Under ‘antiquated’ religious norms (Christian, Jewish, and Muslim) men were culturally, in not legally, financially responsible for any offspring they produced, as well as the mothers of those offspring. Alpha-dominance feminists have removed that obligation, within courts, and society, with their misogynistic and discriminatory ideologies and practices.

In the social structure promoted by the alpha-dominance feminists for the past 50 years, women in the home, family and courts have no rights, but are considered slaves, chattel and pawns. The role that (caring and loving) mothers play in producing upstanding and honorable people and productive and competent future workers cannot be under-estimated, and is ONE OF THE MOST IMPORTANT AND REWARDING JOBS IN THE WORLD. The contention of alpha-dominance feminists that ‘women’s work’ is NOT IMPORTANT and does NOT CONTRIBUTE to the ‘general welfare’ is misogynistic, discriminatory and FALSE!! As I keep telling people in the hospitality and human resource industries, “People are getting paid a Helluva lot of money to do what the courts and society consider ‘unimportant’ and ‘worthless when it comes to mothers and wives, particularly upper-middle class, trophy-wives’!” As long as alpha-dominance women are in control of the rhetoric of the feminist movement, issues such as comprehensive child-care, work-life balance, reproductive rights, gun-control, economic stability, the future of our planet, etc. will NEVER be accorded the attention and priority needed by policy-makers. Instead limited resources will continue to be concentrated on warmongering and hedonistic pursuit by the ruling-elite, at the expense of the masses **and ‘general welfare’ of society**—rendering these ‘democracies’ illegitimate under ‘social contract’ theories.

In order to assure integrity, transparency and accountability in government agencies, as well as the NGOs whose mission it is to oversee these agencies, **it is first necessary to drain all the ‘seat-warmers’ and con-artists who are too busy ‘grappling-up-the-ladder-of-success’ in the ‘Rat-Race’ to care about doing their jobs, or fulfilling the mission of their organization.** ICD is a perfect example, and ‘petri dish’, of a totally mis-managed department which is milking citizenry of their hard-earned wages, while contributing to, and escalating, the chaos in the world—in direct contradiction to its mission. The games being played by Sharmini Coorey, Gina Paone, Adrienne Thapa, Imel Yu, Carla Cullati, Jocelyn Vanderhaegen, Kathryn Nelson-Indre, Kate Phillips, and Ana Daie in collusion with IMF HR (with Kalpana Kochhar taking the lead), as well as its cover-up by Olivia Graham (Ethics Advisor), Geetha Ravindra (Mediator), Lois Petzhold (Ombudsman), and Sabina Blaskovic (Special Investigator) are TYPICAL of what is going on in government agencies, and NGOs throughout “[This Town](#)” (Mark Leibovich)—and why Trump won with a promise to “drain the Swamp.”

Please see my complaint, “[Workplace Bullying in the IMF](#)” filed with IMF HR (Mark Plant and later Kalpana Kocchar), its Ombudsman, Ethics Committee, and Mediator in March ’16, as well as with the ‘Special Investigator’ hired by Christine Lagarde in July ’16. The only person I ever heard back from was the Ethics Advisor, Olivia Graham, who laughingly claimed “insufficient evidence to launch an

investigation”—providing me with a ‘slam-dunker’ case against the IMF, and ICD for the international courts, under labor violations. Another, perfect example of negligence of civil servants and its violent consequences, is the recent school shooting in Florida. In the case of this young man (Nikolas Cruz), not only were [police called to his home 39 times in a 7-year period](#), but Florida FBI agents ignored a report that he “[possessed a gun and the desire to kill](#).” The manner in which ‘authorities’ are systematically occulting and ignoring evidence of abuse and bullying within homes, work-place, schools, and communities is CRIMINAL, and it is high-time they are investigated, and held accountable for their EXTREME NEGLIGENCE—and the violence it is creating. Not only do these people need to be held accountable in penal and civil proceedings in order to bring justice to their victims, but they need to be made an example of, as a deterrent to others in government agencies.

Unfortunately, as this past year has shown, not only is Trump NOT draining ‘The Swamp’ as I predicted over a year ago, but he is inundating it with more and more ‘game-players’ from the corporate world as well as from groups of white-supremacists. One of the latest additions to ‘Trump’s Swamp’ is Director of the Federal Trade Commission (FTC), Joseph Simons, an “[anti-trust lawyer who has represented tech giants like Microsoft](#)”—who, coincidentally, is the step-father of a manager in a restaurant where I work at present, and **my bully *du jour***. This woman is the perfect example of the quintessential, giggling, incompetent dumb-blonde—and why white-supremacists want to ‘corner the market’ on the job market. In a job market based on Adam Smith principles of ‘free-trade’ and ‘open-competition’, this woman would never be given anything but the most menial of tasks. The nepotism networks that have empowered her, as well as many other incompetent people I have worked with, or for, since my return to ‘The Swamp’ in ’09, is ASTOUNDING. The level of unethical and illegal behavior of this woman (in my regard, and in general in her work) is equal, and similar, to that I observed, and experienced in the IMF at the hands of Adrienne Thapa, and other ‘queen-for-a-day’ secretaries. It is precisely because labor-markets are INUNDATED with INCOMPETENT personnel that ‘free-trade’ and Adam Smith economics are NOT WORKING as he predicts. “The fault lies not in our stars, but in ourselves.”

For decades labor-forces have been inundated and dominated by unethical and incompetent employees at every level. And, it is these incompetent and psychopathic networks which currently hold the reins of power, as they hold the jobs, and economic power. The only thing ‘diversity’ efforts, coupled with affirmative action, of the past 5 decades has accomplished, is to enable bullies of all colors and genders to ‘rule-the-roost’ in the workplace, and society in general. But, as my case, and under-employment, dramatically demonstrates, it HAS NOT provided equal opportunity for people from a wide variety of back-grounds. I have experience in an extremely wide variety of domains, both at the intellectual, academic level, as well as managerial and administrative levels—and even in my culinary and equine talents. However, NO ONE wants me in their work-place, exactly because my background and experience is so diverse and extensive—making me a threat to their ‘expertise’ and incompetence. This is a human resource problem, and can only be addressed through HR management solutions, in industries across the board. What I am consistently observing, and documenting, in my places of work is the extent to which managers are doing what ONE SHOULD NOT DO, with their micro-managing, dis-organization, chaos, and ludicrous, counter-productive practices.

EVERYONE implicated in my cases are well aware of my work in violence against women (VAW) as human rights violations, and the fact that I am THE EXPERT of the ‘experts’ in that arena. They have also been duly informed that I will be making an example out them, and pursuing them into international tribunals, as well coverage by the press—[however long it takes](#). It appears that with the Trump Administration over-flowing with domestic violence perpetrators, and their cover-ups, the press is starting to take interest in the issues. Unfortunately, these ‘seat-warmers’ are all so sure that they are protected

members of society and can get away with even the most heinous of crimes—because they do it “all the time.” However, contrary to absolving perpetrators from legal liability, it is rendering their crimes to crimes against humanity under art. 7 of the Roma Statutes. Regrettably, since these ‘ladies’ are continually getting away with their ‘game-playing’, right under everyone’s noses, they are demonstrating the extent to which the IMF is run like a mafia and protection racket—implicating all of its employees in labor rights violations, criminal offenses and their cover-ups. Unfortunately, as seen time, and time again, the IMF is not alone, but rather exemplary of what is going on in all the NGOs, as also seen in the case of the [intellectual property theft and rape of Phyliss Chelser by a UN official, and the cover-up by UN employees, during Chesler employ there.](#)

The bullying in ICD, and its cover-up, is a perfect example of how, and why, placing women in positions of power DOES NOT promote equality or democratic principles—and why women have traditionally been excluded from positions of power in the first place. The games of Thapa and ICD’s ‘HR Team’, and its cover-up by Coorey, IMF HR, and its ‘regulators’ is a perfect example of how and why the ‘seat-warmers’ and incompetent workers are colluding in order to rid the work-place of the competent, hard-working, and intelligent workers. The reliable, diligent people make the ‘slackers-n-slothers’ look bad, so of course they want to purge them from their midst. And, HR department (in the public and private sector) are INUNDATED with ‘seat-warming’ and ‘incompetent’ personnel—with Gina Paone a perfect example.

The fact that Coorey, Thapa, Daie, and Ravindra are all of Middle-eastern origin also highlights the fact that the bullying ‘games’ of women in western cultures are no different than the VAW ‘games’ in Indian and Middle-eastern cultures. At the onset of my divorce, my ex-husband promised me I would end up committing suicide, if I left him—well-informed as to the extent women are being discriminated against, and re-victimized in courts and by the domestic violence industry. However, as I have repeatedly told all the scum-bag lawyers and others implicated in my case, I did not bring my children into this world to then abandon them to the psychopaths in power. They can oppress, harass, bully, exploit and torture me all they want, but I WILL NOT commits suicide—like so many other victims. All these psychopaths will have to assassinate me, if they wish to get rid of me. And, their collusion to incite women to suicide provides further evidence as to the fact that their hate crimes constitute ‘crimes against humanity’ under art. 7 of the ‘Roma Statutes’.

John F. Kennedy and Martin Luther King were assassinated for standing up to the same oppressive paradigm and *status quo* that I am denouncing now, and which was vying for power in the ‘60s and ‘70s. Unfortunately, from the ‘80s on, with the help of high-risk/high-yield investing ideologies in banking systems and financial markets, and techy liberalism (under Bill Gates and Microsoft), American society has ‘backlashed’ towards ‘supremacist’ and oppressive ideologies, with Caucasian, Afro-Americans and Middle-eastern power bases vying for power—and creating social tension between races in the process. THIS is the REAL reason that racial tension is escalating in the USA. Trump’s (and Obama’s) entry into Office were just a reflection of extremist social movements (and counter-movements), and their ‘power plays’ by power-bases in the USA, rather than examples of ‘democratic’ process.

As I explained to Mark Lewis in my phone conversation with him in June ’16, when I told him to read my reports and blogs, as a concerned citizen I have an **OBLIGATION** to denounce the predatory paradigm ICD is promoting with its ‘window-dressing’ technical assistance and training programs. Of course it Additionally, the elevated level of ‘ostrich-playing’ in the IMF was a phenomenon I particularly observed during my attendance of the Committee for Capacity Building (CCB) Meeting, and pre-meetings in ’15, during my tenure in ICDSE. **The number of staff ICDSE employs in order to count the number of courses given, with little cognitive analysis of the effect these courses are having on economies (on**

**taxpayers money) is INCREDIBLE.** And, Robert Powell's condescending attitude towards me during my tenure in ICDSE is more proof as to the incompetence of IMF staff (rather than 'proof' of my 'stupidity'). The idea of 'ivory-tower' economists and HR personnel in the IMF that just because I became a 'stay-at-home-mom' and 'trophy-wife' (instead of having gotten in bed with them in their 'Rat-Race' decades before) **transformed me from a 'genius' into a 'babbling idiot' is LUDICRIOUS!!** I have gotten this same 'attitude' from the business and capital venturist community (which I have also thoroughly researched) in my efforts to create [Global Expats](#), and why they are experiencing 70-90% failure and incompetence rates.

As Richard Nixon so aptly stated "You can fool all of the people some of the time; some of the people all of the time. But, you cannot fool all of the people all of the time." And, as [incidents such as the egg-throwing at Mark Lewis while Res Rep in Turkey](#), and comments on the youtube video suggesting that 'grenades or axes' should have been thrown instead, **should serve as a warning to EVERYONE within the IMF as to the personal consequences and dangers that exist due to their 'ostrich-playing'**. **As I have repeatedly explained to IMF Security guards, THEY should be the first to protest against the 'ivory-tower' 'game-playing' of IMF staff. Because when violence in the streets erupts, it is they who will be on the 'front-line of fire' against the angry mobs armed with 'grenades and axes'.** When the bombs begin to explode along Penn. Ave., and death tolls mount amongst these 'front-liners' it will be IMF (and World Bank and UN) staffers, economists, policy-makers, HR departments and Management who will have blood on their hands—and be criminally responsible for the carnage their incompetence and negligence is producing. Unfortunately, as repeatedly seen in history until violence in the streets, and raping and pillaging in homes, begins, the 'protected' members of society will turn a blind-eye to even the most heinous of crimes by their contemporaries—in order to avoid 'embarrassing' un-pleasantries amongst the ruling-class, elite.

And, while some activists, like Wendy Murphy, are suggesting that I incite women into violent protest, **inciting ANYONE into violence is the LAST thing I will do.** In '10 a lobbyist for the National Coalition Against Domestic Violence (NCADV) told me that what was needed was a "new civil rights movement." And, since any effective 'movement' needs a political platform and ideological base, I "rolled up my sleeves" researched ALL the various arenas and produced the reports and rhetoric needed for the new "revolution." Unfortunately, since then I have learned to what extent EVERYONE is more interested in 'becoming famous', getting their books published, and enriching themselves financially; than finding solutions or producing concrete results for victims. The 'fathers rights' initiatives (not to be confused with the 'pedophile rights' initiatives) are correct in their assessment of the DV industry—it is an industry more interested in making money off the suffering of victims, than in protecting or defending them. The reason that people resort to violence is that they are goaded into it by bullying networks, and the failure of 'authorities' to take action. If anyone examines the profiles of 'terrorists', be they white mass shooters or 'brown' suicide bombers, their past, and experience as victims of domestic violence is always omni-present. But, DV 'experts' (lawyers and advocates) are making too much money off the 'business' as are women's rights activists and groups, to have any incentive to challenge the psychopathic, alpha-dominance ideologies which is the motor behind the entire matrix.

One of the saddest stories of the **consequences for IMF staff** of the paradigm the IMF, World Bank and UN are maintaining and promoting was the killing of the son of former ICDGP Director Effie Psalida ([Alexandros Peterson](#)) in Afghanistan in '14. I am sure Effie Psalida will repent her part in funding ICD's initiatives when she learns to what extent they are contributing to the networks and terrorists cells which are fueling the escalating violence that killed her son. Not only has US military interests (and for-profit weapons makers) been a major influence in the escalation of violence in the region for decades, but the

American alpha-dominance feminists are actively and directly ‘adding fuel to the fire’ in the ‘exportation’ of their dysfunctional and oppressive ideologies to countries around the world.

While it is the responsibility of ICDSE to be evaluating the effectiveness of ICD’s training programs and technical assistance, it is ICDGP which is the ‘motor’ behind those programs, as it is they who are procuring much of the funding for them. And, while Robert Powell is the typical white, male-supremacists, and therefore in ‘his nature’ to be promoting the current oppressive paradigm, in my limited knowledge of Mark Lewis’s character, he appeared to be a conscientious, hard-working employee—albeit a victim of the ‘techy liberalism’ of Bill Gates and Microsoft in collusion with the IMF IT department. He appears to be a well-intentioned policy-maker, who is just “in with the wrong crowd.” Hopefully, he might take heed from being a victim of an ‘egg-throwing’ experience in Turkey years ago, as Director of ICDGP—and start to question the direction, policies and ideologies dominant in the IMF, and their destructive consequences, along with anger produced in effected populations.

One of the many ‘players’ I have contacted in the past decade, in ‘The Swamp’ in my efforts to OBLIGATE American Consulates around the world to START DOING THEIR JOBS (by launching a Congressional Oversight Hearing on the State Department’s incompetence), is [Dee Martin](#), a board-member of the Feminist Majority Foundation (FMF), and Founding Partner of the Policy Resolution Group at Bracewell, LLP. However, while Ms. Martin found my analysis and argumentation of pertinent issues IMPECCABLE, she required a \$20,000 retainer fee “to start,” with the final price tag in the hundreds of thousands, if not millions. (Of course I do not have this money because EVERYONE keeps trying to marginalize and oppress me, as well as defraud me of the little money I am able to save.) And, when I suggested that FMF could ‘foot the bill’ for the ‘Oversight Hearing’ she responded that FMF is too busy ‘helping women in Afghanistan’. What everyone in the development community are failing to recognize is the extent to which alpha-dominance feminists are the motor behind escalating violence amongst men, particularly evident in the Middle-east, and growing number of suicide bombers and terrorists.

During one of the seminars in the ‘16 IMF/World Bank Spring Meeting, an African woman from the audience explained how women in Africa are being turned into slaves by western-style feminism and their women’s ‘rights’ movement. (See my blog [Men, Women & Sex Ed for the Feminists: Observations of a CSO Rep at the IMF/WB Spring Meetings – Part 13](#)). The damage alpha-feminists and their psychopathic organizations are creating in societies around the world CANNOT BE UNDERESTIMATED. If EVERYONE, starting with my lawyers in Spain, in collusion with my ex-husband and the courts had not prevented me from creating [Global Expats](#) in ‘06, its annual income would be several billion dollars per year at present. And, I would have ALL the money I needed to combat the ‘House of Cards’ that the alpha-dominance feminists in collusion with the white supremacists, having been building for decades, and centuries. **I would additionally have all the ‘experts’ and ‘queens-for-a-day’ who are currently looking down their noses at me, sucking-up and doing my bidding like there was no tomorrow.**

Amnesty International, Spain estimated that my chance of survival in Spain in ‘08 was ¼ of 1%. And, while against all odd I survived, and made it out of Spain alive, my brain was completely frazzled from years of psychological abuse from my ex-husband as well as the courts and useless domestic violence NGOs. It is in part thanks to what I learned from my body-guard in Colombia that I was not killed in Spain in ‘07-‘09. Leaving my children in Spain with their psychopathic father and his family was the hardest and most heart-wrenching thing I have ever done, **but I knew I would be of no use to them dead.** My case demonstrates the lengths people will go to in enabling domestic violence perpetrators, human-traffickers, pimps and money-launderers, while doing EVERYTHING in their power to silence,

marginalize and oppress ‘whistle-blowers’, particularly women, victims of domestic violence, and above all those who fight back. **Extremism, violence, and civil unrest are on the rise because ‘public authorities’ and ‘civil servants’ EVERYWHERE are working in collusion to empower the criminal elements in societies, while silencing and oppressing victims.**

One of the most vicious, and heartless people involved in my various ‘sagas’ in the past decade is former Chair, Anne-Beatrix Keller Semadeni. The manner in which she, and all the IMFFA board members, exploited a poor woman who had already been through Hell and back, and was worried sick about her children and their future, on top of facing horrific housing rights abuses by landlords and cohabiters; exposes the truly elevated level of amorality and psychopathologies of the IMF and its staff. The apathy of IMF staff towards the bullying and labor rights violations throughout the Fund just exposes the lack of professionalism in the organization, as well as the lack of morality, humanity and respectability of its employees. (And, Joseph Stiglitz and the NGO, [Knowledge Ecology International’s](#) cover-up<sup>1</sup> of Keller’s crimes just exposes the level of apathy, narcissism, and collusion of those within the development community to the elevated level of criminality in their industry.) It is precisely because ‘Expat Wives Clubs’ are infected with vicious back-stabbing, social-climbing vipers that I came up with the idea to transform the model into a ‘for-profit’ organization—naively thinking that if these ‘ladies’ were paid for their work, they would be more honest, diligent and honorable. My 7-year tenure in the IMF, and lobbying of the ‘development community’ for the past decade, has taught me to what extent this industry is infected with predators and opportunists, who are completely lacking in integrity, honor, self-respect and dignity.

It should be noted that art. 143 and 607 bis<sup>i</sup> of the Spanish penal code (under universal jurisdiction), clearly shows that the ‘games’ everyone is playing in the IMF, World Bank, UN, and throughout the development community are criminal offenses and crimes against humanity (art. 7 of Roma Statutes<sup>ii</sup>) due to the fact that they are principally targeting women, as well as being racially motivated. As my research has constantly demonstrated, minority women who have been empowered by affirmative action programs, are the most vicious and prolific abusers; and are particularly targeting upper-class, white women as ‘pay-back’ for previous injustices. At the international level, it is the Middle-eastern women who are the most problematic, and within the USA it is Afro-American women. Since my return to the USA, and DC, in ’09, I continually been the target of bullying, in work-places, as well as by landlords, and ‘room-mates’ in the group homes in which I have lived. Not only are two black women, and former landlords (and lawyers) looking at criminal convictions under perversion of the course of justice, perjury, pre-meditated extortion, harassment and hate crimes, but they are risking loss of their homes in civil suits, for damages incurred. The quantity of lawyers committing criminal offenses, as well as enabling their clients to perpetrate crimes, is of CRISIS PROPORTIONS.

The first head-hunter I met with in ’09, upon my return to Washington, and the remunerated work-force, told me she was going to have a hard time finding me a job, because anyone interviewing me would be

<sup>1</sup> Spanish Penal Code, [Article 451](#)- Whoever has knowledge of a felony committed and, without having intervened in it as a principal, subsequently intervenes in its execution, in any of the following manners, shall be punished with a sentence of imprisonment of six months to three years:

1. Aiding the principals or accomplices to benefit from the gains, product or price of the offence, without intending personal profit;
2. Hiding, altering or destroying the evidence, effects or instruments of an offence, to prevent it being discovered;
3. **Aiding the suspected criminals to avoid investigation by the authority or its agents, or to escape search or capture...When the person abetting has acted in abuse of his public functions,**

[Article 29](#)- Accessories are those who, not being included in the preceding Article, **co-operate in carrying out the offence with prior or simultaneous acts.**

afraid that in 6 months I would have their jobs. And, time and time again this has been my problem everywhere I have worked, and in every interview I have had. I am having the same problems in the restaurant industry where I am employed at present as I had in the IMF, demonstrating the commonality, and pervasiveness, of the situation in public and private sectors. One of my ‘favorite’ examples (and cases) is the General Manager of one restaurant which openly admitted to running a “dictatorship.” The psychopaths in power in ‘The Swamp’ are of crisis proportions, and inundate workplaces at every level, and every arena. **These are the ‘respectable members’ of ‘the Swamp’?!** Then, all these psychopaths believe that they can absolve their souls, by making generous and public donations to charities (ie. IMF ‘Helping Hands’)—which are matched by their employers, and therefore taxpayer’s money. However, the only people they are fooling are themselves, and their partners in crime, in ‘The Swamp.’

One of the residual, and negative, effects of alpha-dominance feminism, and their contention that placing women in positions of power will promote democratic principles, is that they are reinforcing the machistic belief that the administrative function (in the work-place and home) is ‘unimportant’. EVERYONE wants a managerial, or ‘expert’, position, with ‘too many chefs, spoiling the soup’. Administrative positions are not properly appreciated in the workplace or society. It is the belief that these jobs are ‘unimportant’ and can be done by “any idiot” with which organizations are justifying the bullying of support staff into submission and silence. No one dares to complain, because if they do, they become a target of the bullying networks who will ‘get rid of them’; while those in power (managers and courts) turn a blind-eye to all evidence of wrong-doing. **The manner in which Jocelyn Vanderhaegan and Carla Cullati ‘worked’ me, goading me to file a complaint against Elizabeth Elliott, Adrienne Thapa and the ICD’s HR Team, so that I, not them would become the target of any ‘ousting’ attempts, was truly COMICAL.** My ‘favorite’ was when Jocelyn told me to wear mini-skirts to work, because my “skinny legs would make Adrienne furious.” And, I wore not only mini-skirts, but fish-net stockings in for good measure—really infuriating Adrienne as ‘pay-back’ for her bullying. As I explain to people in telling these stories, it is unacceptable for women to handle altercations like men—who will punch their adversaries in the face, and be done with it. Women have much more subtle ways, verbal and non-verbal, ways in which we deal with adversaries! And, petty ‘jealousies’ between women is our greatest ally!

Phyliss Chesler in her book *Women’s Inhumanity to Woman* explains all the bullying tactics of women (which the alpha-feminists are extremely adept and prolific in using), but is perplexed why fathers do not protect their offspring from bullying mothers. However, what she fails to understand is that most men, alpha-linear thinking ones particularly, simply do not understand the nuances of social interactions and communications of abusive women, and do not know how to protect their daughter, nor themselves, from the back-stabbing manipulations. She also fails to understand how, and why, the failure of women within the feminist movement to counter-attack, alpha-dominance feminism, and its forces in society, is just like the failure of men in to protect their daughters from abusive mothers. Chelser (who walked out of my presentation “[VAW as Human Rights Violations](#)” at the Battered Mother’s Custody Conference ’15 (BMCC XI), 10 minutes after it started) talks about the bullying she was subjected to by the feminists in writing her book. **However, she is doing nothing to expose these bullies or bring them to justice.**

One of my big deceptions at the BMCC conference was observing to what extent speakers and attendees, attended exclusively in order to socialize and pass out business cards. I observed this same phenomenon at the IMF/WB Spring Meeting ’16 by other attending CSO Reps—again with dismay, above all since I was beginning to notice another trend of laissez-faire policies and cover-ups. As I have repeatedly observed in my research, ‘activists’, like ‘experts’, are only interested in is getting invited to all of the parties, where free food and booze copiously flows at great expense to taxpayers. Even Michelle Alexander, author of [The New Jim Crow: Mass Incarceration in the Age of Colorblindness](#), told me “You



are biting off an apple, bigger than I am willing to chew” when I contacted her about assisting me in submitting cases against the American, Spanish and French governments to international courts. Everyone (even journalists) know that they can ‘speak-out’ against these governments, as much as they want, but anyone who is willing to take action against them will be destroyed and draconically silenced and oppressed. I stop caring a long time ago if I live or die, and the ONLY thing which keeps me fighting ‘David vs. Goliath’ battles is my love for my children, and the fact that I would move heaven and earth for them—**contrary to everyone in ‘The Swamp’, whose children (and spouses) are nothing other than trophies and pawns in their sick little games.**

Feminist/activists such as [Anne-Marie Slaughter](#) (*Unfinished Business: Women Men Work Family*) and [Leslie Morgan Steiner](#) (author of *Mommy Wars: Stay-at-Home and Career Moms Face Off on Their Choices, Their Lives, Their Families* and *Crazy Love*) are perfect example of this phenomenon. They expose the same problems in their books, writing and speeches as I in my reports and blogs. However,, while these women are VERY VOCAL about the issues (and enriching themselves enormously in the process), they are consistently failing to DO ANYTHING about the problems—and become complicit to the abuses of power of their contemporaries, and the chaos they are producing, by their omission of action. Anne-Marie Slaughter, who is the President of ‘New America’, also held positions of influence and power as Dean of Princeton’s School of Public Policy, Director of Public Policy at the State Department, and President of the American Society of International Law. **And, should be ASHAMED of herself!!**

Slaughter is a perfect example of how those in power are unable to translate their rhetoric to reality due to their lack of integrity and strength of character. Slaughter, with a budget of \$158 million and hundreds of staffers at her disposition should be calling out Christine Lagarde, Jim Yong Kim, and Antonio Guterres and demanding accountability, instead of climbing into bed with them with the ‘window-dressing’ initiatives of ‘New America’. Trump won with a promise to “drain The Swamp” because people like Slaughter, and NGOs like ‘New America’ are typical of those found in the Swamp with EVERYONE too busy partying and cashing paychecks-and-pensions from shareholders or taxpayers to DO THEIR JOBS with even a minimum of integrity or honor.

As I continually point out in my blogs, if Bretton Woods I was doing their jobs with a minimum of integrity and transparency, then there would be NO NEED for the [Bretton Woods II](#) of ‘New America’. Slaughter talks extensively about how she gave up her ‘high-power’ job at the State Department after a two year separation from her adolescent sons, who “needed her.” It has been 10 years since I have seen, or spoken with my two sons—with every passing day filled with horrific pain and suffering. However, I count my blessings that they are not being savagely raped and tortured with me powerless to protect them like millions of mothers and their children, victims of family courts. Millions of children are being savagely raped and beaten by custodial parents with courts sanctioning these atrocities, while Slaughter plays the concerned, caring parent to cover-up for her “selling-out” to the Democrats and Clintons. Slaughters sons are going to finish their lives in a Third World War, or struggling to survive on a dying planet, so that she might have reveled in power and glory for a few fleeting years! EVERYONE supporting the present paradigm should think hard, about how they are going to explain to their children, that they sold them out for a few years of fame, glory and hedonistic pursuits.

As I told ‘queen-for-a-day’ Imel Yu and Kathryn Nelson-Indre when they thought they could silence me, by black-listing me from attending the IMF/World Bank Annual Meetings in ‘16 “not only have I shown the world that I could do a better job of running ICD than Adrienne Thapa or Sharmini Coorey , but I could do a better job of running the IMF than Christine Lagarde!” (in my coverage of the Spring Meetings<sup>iii</sup>). Unlike Lagarde, I am not willing to sell my sole to the Devil for a few years of fame and

glory—with my children paying the price later in life. Michael Lewis was right in his “One-on-One with Christine Lagarde,” when he said she was being set-up as the ‘fall-guy’ when the ‘House of Cards’ in ‘The Swamp’ comes tumbling down on everyone’s head. And, when financial markets and banking systems finally collapse again, Lagarde is going to be very embarrassed when she must explain to the press and public why the only person at the IMF to know WHY markets collapsed, AND WHAT TO DO ABOUT IT, was fired by a lazy, incompetent ‘queen-for-a-day’ secretary, made Office Manager—whose claim to fame is typing 75wpm, and is “known for sexually harassing men.” It is truly incredible the number of people in the world willing to implicate themselves as accessories to crimes, and risk their financial security and careers, in order to cover-up for sexual predators and bullies in their midst—in order to avoid “being rude” and having to deal the “un-pleasantries” of life.

On the day Imel Yu and Kathryn Nelson-Indre decided to black-list me from the Annual Meetings, I had spent the entire morning in DC Landlord/tenant courts (after putting up with 4 months of THEIR ‘game-playing’) collecting evidence with which to challenge the defense of the American government in [Gonzales Lenahan vs. USA](#), 2011, the 1<sup>st</sup> jurisprudence on VAW as a Human Rights Violations—once I can find a lawyer, or law firm with the BALLS to submit the cases to international courts. Additionally, in what ended up being an 8-month battle in DC Landlord/tenant court, I was able to produce the evidence needed in order to launch a full-scale investigation into the predatory nature of the American court system, and the systemic violation of rights within them—see my letter to [Jeff Sessions](#), **noting that what I am calling for is what former President Obama should have initiated during his tenure as President!** The fact that Obama did NOTHING to challenge and dismantle the [New Jim Crow](#) during his 8-years, and two term, presidency just demonstrates to what extent he, and his Administration sold their souls to the Devil, as well as to the white-supremacists *status quo* to the detriment of the entire Afro-Americans population.

As I told my classmates at the time, “forget EVERYTHING Dr. Dunn has said. He is complicating his subject matter too much.” The *callate tonta* game that EVERYONE in the IMF played with me during my tenure there, particularly ICD, is the same game my lawyers and Spanish courts played with me in ’07-’12. It is also the same ‘game’ my ex-husband and his family played with me my entire marriage, and the same ‘game’ my mother and younger sister have played with me my entire life. So I am well familiar with the tactics, as well as the fact that it is motivated by stupidity and jealousy on the part of the bullies—rather than any veracity of my stupidity or feeble-mindedness. In fact, anyone who thinks being a ‘genius’ is something to which one should ‘aspire’, is sadly mistaken. Not only does being intelligent, and ‘sensitive to others’ enable one to “see” what others cannot, but it attracts vicious, viperous back-stabbers like ‘bees to a honey pot’.



Jones is worshipped by the US Marines, and the Naval Academy in Annapolis is a [monument to his courage and bravery](#). If all the ‘seat-warmers’ and ‘sell-out artist, experts’ continue on their present trajectory, and the US descends into a blood-bath and Civil War; I will hopefully be able to rally the US Marines to fight for the principles upon which this country was founded, instead of supporting the white supremacy and racism of Trump and his administration.

<sup>i</sup> Spanish Penal Code

*Article 143*

- 1. Whoever induces another to suicide shall be punished with a sentence of imprisonment from four to eight years.*
- 2. A sentence of imprisonment of two to five years shall be imposed on whoever co-operates in the necessary acts for a person to commit suicide.*

*Article 607 bis*

- 1. Conviction for crimes against humanity shall befall whoever commits the acts foreseen in the following Section as part of a widespread or systematic attack on the civil population or against part thereof.*

*In all cases, committing such acts shall be deemed a crime against humanity when:*

- 
1. Due to the victim pertaining to a group or community persecuted for political, racial, national, ethnic, cultural, religious or another kind of reasons, disability, or other motives universally recognised as unacceptable under International Law;
  2. In the context of an institutionalised regime of systematic oppression and domination of a racial group over one or more racial groups and with the intention of maintaining such a regime.
  2. Those convicted of crimes against humanity shall be punished:
    1. With a sentence of imprisonment from fifteen to twenty years if they cause the death of any person. A punishment higher in one degree shall be imposed if any of the circumstances foreseen in Article 139 concur;
    2. With a sentence of imprisonment from twelve to fifteen years if they commit rape, and from four to six years imprisonment if the act were to consist of any other type of sexual assault;
    8. With the punishment from four to eight years imprisonment if they commit serious torture of persons they have under their custody or control and of imprisonment from two to six years if less serious. For the purposes of this Article, torture shall be construed as submitting a person to physical or mental suffering. The punishment foreseen in this Sub-Section shall be imposed without prejudice to the relevant penalties, as appropriate, for the violations of other rights of the victim;
    9. With a sentence of imprisonment from four to eight years if they commit any of the conducts related to prostitution defined in Article 187.1, and with that of six to eight years in the cases foreseen in Article 188.1. The punishment shall be imposed from six to eight years on whoever transports persons from one place to another with the intent to sexually exploit them, using violence, intimidation or deceit, or abusing a situation of superiority or need or the vulnerability of the victim. When the conduct foreseen in the preceding Section and in Article 188.1 is committed against minors or the incapacitated, the higher degree penalties shall be imposed;
    10. With a sentence of imprisonment from four to eight years if any person is subjected to slavery or kept in servitude. The punishment shall be applied without prejudice to the appropriate ones for the specific violations committed against the rights of persons. Slavery shall be construed as the situation of a person over whom another exercises, albeit de facto, all and some of the attributes of the right of property, such as buying, selling, lending or exchanging such person.

#### Article 451

Whoever has knowledge of a felony committed and, without having intervened in it as a principal, subsequently intervenes in its execution, in any of the following manners, shall be punished with a sentence of imprisonment of six months to three years:

1. Aiding the principals or accomplices to benefit from the gains, product or price of the offence, without intending personal profit;
2. Hiding, altering or destroying the evidence, effects or instruments of an offence, to prevent it being discovered;
3. Aiding the suspected criminals to avoid investigation by the authority or its agents, or to escape search or capture, whenever any of the following circumstances concur:
  - b) When the person abetting has acted in abuse of his public functions. In this case, in addition to the punishment of custodial sentence, that of special barring from public employment and office for a term of two to four years shall be imposed if the felony concealed is less serious, and of absolute barring for a term from six to twelve years if it is serious.

<sup>ii</sup> Roma Statutes of the International Criminal Court

#### Article 7: Crimes against humanity

1. For the purpose of this Statute, "crime against humanity" means any of the following acts when committed as part of a widespread or systematic attack directed against any civilian population, with knowledge of the attack:

- (a) Murder;

---

(e) Imprisonment or other severe deprivation of physical liberty in violation of fundamental rules of international law;

(f) Torture;

(h) Persecution against any identifiable group or collectivity on political, racial, national, ethnic, cultural, religious, gender as defined in paragraph 3, or other grounds that are universally recognized as impermissible under international law, in connection with any act referred to in this paragraph or any crime within the jurisdiction of the Court;

(k) Other inhumane acts of a similar character intentionally causing great suffering, or serious injury to body or to mental or physical health.
