Dear Mr. Love,

I am contacting you regarding Ms. Anne-Beatrix Keller Semadeni, Director of Development at Knowledge Ecology International (KEI). I was the sole employee for the IMFFA during the entire tenure of Ms. Keller as Chair of the IMF Family Association. And, it was I who, not only had all of the ideas that transformed the IMFFA from what is was prior to Ms. Keller's tenure to what it is today. But it was also, I who did all the hard work, not only in administrative duties in providing a framework for the office and organization, but also in managing the chaos Ms. Keller produced in her function as Chair. Ms. Keller has absolutely no managerial or management skills, and does nothing but create havoc with her micromanaging.

One of the major problems with 'Expat Wives Clubs' is that they are antiquated orgs, filled with "wives" who want remunerated jobs and careers, and the bulk of women or men who volunteer for these positions do so, because it helps their husband's careers (noting Ms. Keller's husband was offered the post as Res Rep in Togo after Ms. Keller's tenure as Chair of the IMFFA). Another reason women volunteer for these positions, is the elevated social status it affords them within the expat communities they serve. Unfortunately, that is about all they do (and why membership rates for even the "best" of these orgs (ie. www.fawco.org) are at 0.1% of the expat populations they serve), Please find attached a presentation, which explains the concept and structure of Global Expats. What Ms. Keller, Ms. Happel, and the IMF have done with the IMFFA in the past 5 years is nothing more than "window-dressings" and smoke screens.

I have been in the work-force since 1979, in a wide variety of activities, industries, and functions. Never have I work with anyone as chaotic and disorganized as Ms. Keller. Additionally, Ms. Keller has neither the academic, nor intellectual level for the position she currently holds. I can only surmise that Ms. Keller is continuing to promote my ideas as her own (to economist like Joseph Stiglitz, whose economic theories parallel my own of the past 30 years, and obviously through whom she was considered for a job with KEI). However, on this occasion Ms. Keller is totally beyond her capabilities and capacity, as she is in no way, shape or form qualified for the position she holds. However, I am -- see my Linkedin profile. And, under all standards of fairness believe I should be considered for this position, along with any other candidates.

Also, please find attached a complaint I filed on March 8, 2016 with the IMF over my wrongful termination for activism work, and bullying in the Institute of Capacity Development (ICD). As you will note in the complaint, instead of combating bullying in the workplace, too many organizations are promoting it. During my tenure at ICD, they held 2 "Respectful Workplace" workshops, in efforts to address widespread bullying in the Fund. As you can additionally see in the complaint, bullies in the workplace use the same tactics as bullies within the home--the principle area of my research and activism work of the past decade. Unfortunately, many of the HR "solutions" to address bullying are nicely package workshops and seminars, which gloss over the issues with lots of rhetoric and jargon, with everyone missing the more ominous underlying messages-- turn a blind-eye.

As you might surmise from my present <u>blogs on Linkedin</u>, the problems of bullying with large bureaucratic orgs in DC (and elsewhere) is not benign, but a serious global issue.

I have not heard from the IMF, so I can only surmise, that Mr. Plant is turning a blind-eye. I have also contacted Global Employment, the temporary employment agency who was my actual employer during my tenure at the IMF (over the issues concerning my wrongful and illegal termination by Ms. Keller in 2011) with no response to date. I will be pressuring Global Employment to take issue, legal if necessary, with the IMF, as it is imperative that employment agencies, with their stock of lawyers, etc. start defending workers rights. The failure to do so renders them complicit to the original violation of rights. As Ms. Keller knows from reading all of my blogs and socio-economic development theories, etc. I am preparing to present a case against Spain, to CEDAW, for human rights violations and their failure to protect me and my children. I will also be detailing my and my children's re-victimization by the courts, naming the US Consulate and State Dept. as complicit in their omission of action. All of the violation of my rights (see www.warondomesticterrorism.com) of the past decade, by the courts in Spain and by employers (IMF, IMFFA, Global Employment) and landlords in the USA will be included as testament to the dire state of affairs for marginalized displace persons and refugees of violence. These people are fleeing violence only to be exploited by unethical and unscrupulous people like Ms. Keller and Ms. Happel. And, society and courts are complicit to that exploitation, by turning a blind eye. See my blog on IMF/WB Spring Meetings 2016.

Unfortunately, since I have received no word from the Fund, nor Global Employment, I have no other option than to seek redress in the press (see <u>press release</u>), and would like you to be informed as such. I do regret the uncomfortable position that you, I and KEI, as well as Mr. Stiglitz, has been put, as I am sure he is of good faith. (I had the opportunity to observe Ms. Keller's behavior, social networking, social climbing, etc. and I am sure she has manipulated Mr. Stiglitz as <u>is her nature and manners</u>.) As I stated earlier, I believe under all standards of fairness, I should be considered for the position Ms. Keller presently holds, a position for which she in neither qualified, and obtained under false pretenses.

Again I apologize for a situation that is difficult for you, me, Dr. Stiglitz, and KEI. However, it it not I who has created this situation. That has been done by Ms. Keller and the IMF. Dear Mr. Love,

Thank you for your response. I had no way of knowing if you had received my email, and why I personally delivered a copy to KEI. I appreciate the fact that your organization is not hiring at present. Damages in my case against Spain and the USA are around \$10B and climbing, so I am not too concerned about any position with KEI, thank you. I admittedly have a cash flow problem at present, caused by people like Ms. Keller. But, that is a temporary situation, I can assure you. People in my familly (<u>Thomas Wilcox</u>, John Dickinson, John Paul Jones, my grand-father (see my blog <u>Harper Lee's</u> <u>Passing: A Legend Dies, But Not Sa Raison d'Etre</u>.) and my father have successfully been fighting Goliaths for centuries.) And, while I have been in the VAW/DV "War" for almost a decade, the Winds of War are changing. (My life resembles more that of John Paul Jones than John Dickinson, but as I always say "the plume is mightier than the sword.")

My issue with Ms. Keller's position with KEI as Director of Development is more the fact that Ms. Keller is holding a position with an NGO in DC that she is totally unqualified to hold, and could have only obtained through nepotism, or intellectual property theft. I worked with Ms. Keller for over a year, and she is totally unqualified to hold the position she does at present. Everyone on the board of the IMFFA as well as those within IMF multimedia can attest to what a menace and disaster this woman is. And, since her position as Chair of the IMF is the only job Ms. Keller has ever done that would even remotely qualify her as Director of Development in an NGO, I know for a fact she is unqualified. And, everyone in the Fund who knows me, and Ms. Keller, knows it. I have been denouncing this type of behavior of NGOs all over DC for years, often quoting Laura Nader's book, *Anthropology of Law.* (I have also just denounced the National Partnership for Women & Families, in my blog *The Emperor & His Entourage are "Buck-naked" in "This Town.*" for this type of behavior.) As Nader points out, the rule of law in the USA is gone because of mediation and arbitration. This is exactly what I am demonstrating in my official complaints with the IMF at present within their grievance process. I have met with their mediator and

Ethics Committee. Now I have to prepare a complaint to the IMF Ombudsman, see my blog <u>Ethical</u> <u>Questions in Gender-Neutrality and Favoritism</u>, denouncing the behavior of the IMF Ethics Committee. Basically, as I explain in my blogs. The strategy *du jour* of NGOs and regulatory agencies is just ignore victims of abuses of power until they go away. I have been documenting this behavior in regulatory agencies and NGOs for almost a decade now.

What Ms. Keller and the IMFFA are doing at present in relation to VAW/DV issues is the same as the Federation of American Women's Club (FAWCO) and their UN initiative. All of these orgs are building the same "smoke-screens" to cover-up for the reality of the situation. What the Expat Wives Clubs like IMFFA and FAWCO are doing at present is what I call "pulling a Nancy Reagan". (See <u>UN FAWCO Smoke-screens on VAW/DV, CEDAW & Human Rights.</u> also see my report <u>FfD: A Midsummer Night's Dream</u>, which explains in further detail, how nepotism, favoritism, and inertia in NGOs is assuring that the SDGs will never be achieved. Cornelia Guest was a principle actor, then and she can be now, see my blog <u>Fractured Fairytale Deb vs. Deb of the Decade</u>.)

Also, please read all of my blogs <u>Observations of an CSO Rep at the IMF/WB Spring Meetings 2016</u>, which begin with <u>The IMF in Denial!</u>: <u>Observations of a CSO Rep at the IMF/WB Spring Meetings - Part 1</u>. It is only a matter of time before the next financial meltdown occurs, and my blogs explain not only why, but to what extent gross mismanagement with the HR function of the Fund is responsible. I will be submitting these blogs for publication to media outlets when finished. The Fund, especially David Lipton and Jose Vinals are going to look very, very bad when the crash comes, because of all of the ostrich-playing and toadyism in the Fund. (This "stupid" trophy-wife predicted the last crisis, for the same reasons I am predicting this one, when the Fund cannot.)</u>

After my CEDAW case is finished, litigation in the USA and Spain will begin with Ms. Keller, the IMF, and IMFFA implicated, as will be KEI, if Ms. Keller is in fact found guilty of intellectual property theft. I will be contacting Professor Stiglitz as to the situation Ms. Keller has produced. I respect your position. However, I do believe you do need to respect mine. I have been fighting people like Ms. Keller for almost a decade on all of these issues, and will continue to do so. Please see my activism website, <u>www.warondomesticterrorism.com</u>. Her actions, and the actions of those around her who sustain and promote these kinds of situations are rampant in DC, and one of the great problems with the political system at present.

I started this project over a decade ago. So <u>my story</u> is a long one.

But, the idea for Global Expats is basically what Ms. Keller was promoting at the IMF for the IMFFA; information and resources for expat spouse, as well as career networking assistance. And, as I explained in my complaint in March 2016 to the IMF I could care less if IMFFA or FAWCO are using my ideas. Many come from the Expat Wives Clubs I have worked with in the past, one of which is a FAWCO chapter. But, these orgs are supposed to help "trailing spouses" and expat families, and what IMFFA and FAWCO have done (or rather not done) in my case in the past decade is testament to the world and entire global mobility industry that these orgs are nothing but smoke-screens for the multinats and govts. who want to paint a "rosy" picture for expat wives, and are NOT there to assist the families. They are also 'smokescreens' that reward empty-headed trailing spouses to go to the UN each year for their complicity, and to promote husband's careers like in the case of Ms. Keller's husband. (My ex husband rose to his level of incomptence, Director of the Treasury Department of Banco Ganadero/BBVA in Bogota, where he crashed-n-burned those financial mkts in the 90s, was in large part due to me. And, why now he is involved in illegal activity in Spain, which I can do nothing about because of corrupt Spanish lawyers, and vipers like Ms. Keller who are preventing me from moving forward with Global Expats.) FAWCO is doing in the same thing in their <u>CSW blogs</u>, one of which looks like it was written by an 8th grader. Now on top of all of the other reports that need debunking (see my current blogs on the UN report on World's Women, Transforming Economies, Realizing Rights, Human Rights Standards in the Courts Are an Oxymoron, I have to debunk what FAWCO is saying.) Just like the American multinats that sponsor

FAWCO (headquartered in Texas, so guess who the sponsors are). The IMF is using the IMFFA as a smoke-screen as well. When Ms. Keller had me illegally terminated, one of the IMF "trailing spouse" DV victims was in sitting in a DC prison, while the IMF shipped the abusive father overseas with the kids, so he could abuse them without "interruption."

The year before I came to the IMFFA the board was saying that they needed a "professional" to "modernize" the IMFFA. That is exactly what my ideas do. And, if the IMF had search the entire world, they could not have found anyone with more experience and knowledge about "Expat Wives Clubs" than me (see <u>my profile</u>). I knew exactly what needed to be done, and did it. Much of what needed to be done was simply cleaning up the files (which were non-existent in the computer), setting up an organizational system, etc. This was my job and I had no issue in doing it. However, if Ms. Keller had not been trying to pass off all of the ideas for IMFFA as her own. I would have been offered a contractual position with the IMFFA as a "professional" advisor (with a real salary, with which I could have paid for a new prototype website for Global Expats), rather than a \$15/hour job as a secretary, with Ms. Keller manipulating the IMF HR Department to illegally terminate me; and would have been credited with the initiations I suggested.

What IMFFA and FAWCO have produced however have not changed the orgs one little bit. Expat Wives Clubs "real" strength do not lie in a simple structure, like what IMFFA and FAWCO has produced. The real strength of these structures are in the networks of the women involved, and I possess these networks from my boarding schools in England and the USA, as well as my years on the boards of Expats Wives Clubs. I know all of the players, and who to connect them to, in order to "unstall" the feminist revolution. But, I lack the Internet platform I need to connect them all up. If you look at my blogs and social media campaigns across the Internet, I have produced the rhetoric needed by the women's rights groups. Now all of these slackards need to start using them. In 2010 one of the DV lobbyist told me "we need a civil rights movement". And, I just thought, well then what the hell are all of you ladies waiting for. Let's get to it. I have produced the rhetoric they need, now they need to use it. The cheer-leading going on amongst all of the actors is quite tiresome.

That is why I could not care less who is copying my ideas. Two websites with all the techy skills I need for my project, will be on the Internet in a few months, by Silicon Valley gurus who think my idea is great, but can't imagine why they need me (because all of the techy gurus don't understand the marketing function, see my report *FfD: A Midsummer Night's Dream*). Julian Assange calls what is happening in Silicon Valley, "high-tech liberalism" as well as stating that it is very dangerous, and he is right.

It is not so much the "intellectual property theft" that has put Ms. Keller (and everyone else) in such hot water, it was the way she did it. And, the fact that the IMF and its families have been "profiting" from my work and ideas, which Ms. Keller and Ms. Happel took credit for, attempting to destroy me in the process. This is the worst part of the whole scandal Ms. Keller and Happel have produced. These orgs "say" they are helping spouses and families, but the reality is very different. The reason that victims of legal abuse are marginalized and eventually destroyed and homeless, are because of women like Ms. Keller who are maintaining the "House of Cards" in DC and elsewhere. The unethical behavior of the IMFFA, and now the IMF Director of HR, Mark Plant who is just ignoring me--assuming I will disappear, I guess, is really disgusting. All of this has even thrown GWU into the whole mess (see my blog <u>Ostriches May Hide Their Heads, But Toads Profit from It All!</u> & GWU is my alma mater, and the 5th most expensive university in the USA.)

As one of the members of the IMFFA said to me about my illegal termination by Ms. Keller "My God, if anyone should be helping and supporting you, it is an org like IMFFA. This doesn't surprise me. You cannot believe the people who serve on these boards; the screaming and yelling, insults and fights in the board meetings in the past. It's incredible." I just responded "Par for the course with Expat Wives Clubs. Now does everyone understand why I am trying to turn this into a revenue generating org so everyone is paid, and we can hire professionals, instead of social-climbing, back-stabbers, like Anne-B."

No I did not. First, if I had a license to practice law, I would be suing the Spanish lawyers who are the originators of this mess, with one of the top law firms, <u>Cuatrecasas</u>, in Spain, the principle actors. The most logical resolution to this entire mess is for them to pay damages and be finished with the story. However, since everyone implicated wishes for this to go thru the intl. courts first. Then the financial damages, and people who become implicated in violating my rights continues to grow. I have been notifying people for the past 8 years as to their obligation to act, and complicity in failure to act, as you can see in my correspondences to the State Department, Congress and Spanish authorities on <u>www.warondomesticterrorism.com</u>. What I am saying are not threats. I am only stating facts. (This is the problem for societies and everyone involved when "mediation" rather than the rule of law reigns. My financial claim against the courts in Spain has to become the "bigger" party in the matter, before anyone will take action.)

As I said, I cannot sue anyone, as I do not have a license. All, I can do is to point out to people along the way, of their implication in crimes or human rights violations of people in their employ, and who are thereby becoming implicated in the crimes of that person. This is why I have informed you as to the misrepresentation of Ms. Keller, and will be informing Mr. Stiglitz of the same. The entire IMFFA, as well as very many people in the IMF knows very well that Ms. Keller was totally incompetent and inept at her

job as Chair of the IMFFA, as well as the fantastic job I did at the IMFFA, keeping it a float in spite of her erratic and highly unethical behavior.

Ms. Keller psychological manipulating is so bad, that one of her daughters has been under psychiatric treatment because of Ms. Keller's emotional problems. I have a mother like Ms. Keller, who suffers from the *Two Faces of Eve/Mommy Dearest* syndrome of Ms. Keller, and whose manipulations did much to damage my father's career--and something I will be discussing in my own "expose all" book, when this entire mess is finished. Cornelia Guest's mother was the same, and she might be willing to discuss the damage these type of women do to their daughters. And the menace they are to society. Phyliss Chesler opened the door to these issues with Women's Inhumanity to Women, but women victims need to start speaking out.

Please see a letter of recommendation for me from <u>Astrid Betancourt</u> (sister of former presidential candidate Ingrid Betancourt, and FARC hostage), and my friend <u>Piedad Rojas</u> (along with many others in Bogota), who can attest to the extra-ordinary job I did as President of the French Expats Wives Club in Bogota, as well as my many other years serving on these boards, <u>see my profile</u>.) I have people all over the world who can attest to my honor, integrity and transparency. I can assure you Ms. Keller cannot say the same. Also, as you can see from all of my correspondences over the years on my website <u>www.warondomesticterrorism.com</u>, I have always acted with the highest level of integrity, honesty, and honor. Again the same cannot be said of Ms. Keller.

As to how people become complicit to human rights violations even when they might not have knowledge of the original crimes is exactly what Sean Penn had tried to expose to the American people in his famous El Chapo Speaks interview. The trashing of Penn in the press is started my Freedom of Speech in America campaign on Linkedin in the first place, El Chapo, Sean Penn and the Failed War on Drugs. I explain the same "complicity" issues to Barbara Boxer and Ambassador Carolyn Kennedy in the case of Jimmy Ryan and the omission of action of the American Consulate in Madrid in my blog, Jimmy's Wish for Life Shows the Reality Behind the Rhetoric of the Women in Power. In that case, of course Carolyn Kennedy and Barbara Boxer are not directly responsible for the death of this child when he dies. But, when he does, the facts of the matter is that they do have an obligation to act and they are not, so under human rights standards they are legal and criminally liable for their complicity. The same situation is occurring with Carolyn Maloney in the case of Americans Abroad see my blog Carolyn Maloney & the Americans Abroad Caucus, Smoke-screens for Expansionism & Corporate Greed. As you might surmise from my blog for Erin Eddy, The Right to Truth, the Obligation to Protect, and Universal Jurisdiction, I have been lobbying Baltasar Garzon for the past 5 years to initiate cases against governments around the world in their failure to protect victims of domestic violence as well as legal abuse. And, while I have the utmost respect for Garzon, I am also criticizing him for his and Women's Link Worldwide failure to act, in Ostrich-playing by Garzon & Waisman, with Tolls of Death & Dying Mounting.

As I said before I am not threatening you, KEI, or anyone else. I am simply explaining to everyone their implication in a situation, and the ethical and/or legal consequences in their failure to act. Ms. Keller has no qualifications, experience, or has done anything to merit the position she holds at present. And, has even obtained it through lies and misrepresentation. Not only was what she did highly unethical, it was illegal.

There is a serious, serious ethical problem in the USA today, and why bullying is rampant. My case with the IMF and bullying in the workplace is no longer just about my specific case, but to what extent the HR

function is promoting it. One of the major problems with getting action in the UN and CSW is the attitude adjustment that some of the admin personnel need. The problems that bullying in these workplaces are creating are enormous, and the global mobility industry needs to get on the ball in developing solutions, and not some window-dressing BS of The Winters Group and ICD.

KEI has its priority on issues. And, I respect that. However, I have priorities on the issues I am working on as well, and have to respect my own integrity and honor. I have informed you as to Ms. Keller's unethical and illegal behavior while at the IMFFA, as well as my knowledge that it is the only "work experience" which might have made Ms. Keller eligible for the position. And, since that "work experience" was nothing but a farce, and an exploitation of others, it is totally invalid. Other than that, Ms. Keller has only worked as a free-lance translator, with absolutely no professional experience or educational level to merit her consideration for the position she holds at present.

This has NOTHING to do with me liking or disliking Ms. Keller, and your assumption that this is the case demonstrates your gender-bias. Or if Ms. Keller had falsified her resume and added a PhD or MBA after her name, to have obtained her present position, and was exposed, but KEI thought it was "no big deal" because of her personal connections within the IMF. People would be irate. I still have to put together a table for the violations on American soil in the past 8 years, but the table will basically be the same when intl. conventions are concerned; but the "guilty" parties will include Congressional members, State Department officials, White House officials, IMF personnel, and GWU personnel, as well as several citizens, with Ms. Keller, Ms. Happel, and Mr. Harper named as principles.

As to all of the argumentation of how KEI is implicated in any type of litigation, or not, would need an analysis of the Nuremberg Trials, against all of my correspondence to Spanish authorities in the past decades in relation to their obligations to assure integrity and transparency in their courts, as well as the American authorities on their obligation to defend and protect the rights of their citizens abroad (and in the USA) -- see the right-hand side bar on www.warondomesticterrorism.com -- noting that due to time constraints only about 1/2 of my correspondences to "public authorities" are included. (Laura Nader remarks in "The Life of Law" that American (women) are the most prolific letter writers, in consumer protection issues. The entire analysis I have done of the Spanish and then American justice system is basically the same as her Berkeley Village Law Project, with focus on family law issues in Spain, and worker and tenants rights issues in the USA. And, I believe Dr. Nader will agree with me, that never has one American woman written so many irate letters of protest to so many public officials in the history of the entire country, than I have in the past decade--rendering everyone who received a letter, had an obligation to act, and did not do so, complicit to the human rights violations involved. I've been watching youtube videos of Nader, and she and I have very much in common.)

As you can see in all of my research and blogs, the crisis in family courts is the Holocaust of 21st century, with, as we speak, approximately 20 million children living with physically or sexually violent custodial parents, with protective mothers under gag orders, and the threat of incarceration if they speak out. Maria Jose Carrascosa was illegally held in a NJ jail for 8 years, see my blog for her. Erin Eddy's case in VA, is being hounded and harassed by Judge Wiggins, and now Newman who have a child-trafficking ring going on with CPS, see the <u>facebook page of "Victims of Judge Wiggins</u>." Family courts around the world are trafficking women and children, openly and without shame. The lawyers, judges, mediator, the list goes on, have absolutely no shame, and are no different from the Nazis who not only committed terrible atrocities, but closed their eyes to the atrocities of their peers and neighbors. As I stated before, my blogs for Sean Penn, provide a more comprehensive, and analytical explanation of "complicity" issues, which you can read for a better understanding. As you can see in the case of the Holocaust of the 20th century there were many networks of people which enabled Hitler, Himmler and other to carryout their crimes, and it took a whole special court to unravel the "complicity" issues of those implicated, so for me to give a concise explanation of "complicity" is difficult. It also depends to what extent implicated actors, namely the Director of HR at the IMF Mark Plant at present, will take action. As soon as I finish my blogs, I will be preparing a letter for the Ombudsman, and in the hopes that they will launch and investigation into all of my allegations. So "complicity" issues of the IMF, and KEI at present, will be

determined to what extent everyone continues to protect Ms. Keller by their refusal to launch and investigation, confront Ms. Keller, Ms. Happel, and Mr. Harper with their actions, and hold them accountable in an appropriate way--as "justice" requires.

(My suggestion here is that a REAL investigation is launched by the IMF HR Dept. Ms. Keller (and others) are reprimanded for their highly unethical behavior sent to "lick her wounds," IMF and IMFFA recognize their tort to me, and assist me in getting Global Expats up and running. I finally was able to afford to buy an eDirectory proto-type, which houses my data-base; all of the intl. schools, shopping centers, supermarkets, hypermarkets, dept. stores of 131 of the major cities around the globe. I have a more extensive data base for about a dozen cities, see DC. The platform I need is similar to Yelp, Tripadvisor, etc, which cost these days \$100M, and which Cuatrecasas and the other lawyers in my case should be footing the bill for. But, everyone prefers to litigate--more money and fees for the lawyers, while economies crumble around them. I am actively looking for partners and "trailing spouses" to start developing the project, generating revenue as well as a constituency. If Ms. Keller had been smart she would have realized I am not a social-climbing bitch, who would just die and disappear, as Ms. Keller intended, but rather a "socialite" very highly connected in the world, and if she had taken an interest, help launch the project, she would be hob-nobbing with the like of Cornelia Guest and the elite of the East Coast, instead of facing a very humiliating situation at present, that when does "make headlines" is just going to be more humiliating, and for all who have, and are "protecting" her. Just as in the Penn State affair, when the skeletons start coming out of my closet, the world is going to be flabbergast, when the question of "how could so many people have known about this and done absolutely nothing?")

As I stated before while KEI is not directly implicated in any "intellectual property theft," lies, and misrepresentation to the IMF and HR personnel of Ms. Keller in 2010-11. For KEI to be involved in any "theft" at this point, would only occur if they were building an Internet networking platform (cross between tripadvisor.com and yelp.com), positioning it at the "consumer protection agency" of the 21st century for global citizens, promoting the rights of women and children, as well as socio-economic development project for women of all socio-economic backgrounds around the world, in accordance with the SDGs, see slides below. That would be the only situation where Ms. Keller or KEI would be directly violating my intellectual property rights, at present. To my knowledge, this is not the case. You indicated previously that Ms. Keller's work did not violate my intellectual property rights. And, I would be interested to know what Ms. Keller IS working on, particularly after her manipulations while at the IMFFA, and the mess she created there. Additionally, I would be interested in knowing what experience or educational background were considered when considering Ms. Keller for the position of Director of Development. Was it her part-time freelance translating over the years, or was it her year long tenure as Chair of the IMFFA, or her "committee" work in "career development" and "Teen Summer Program" at the IMF, or her BA in the Arts, which qualified Ms. Keller for her position as Director of Development? Or, were it her connections within the IMF that provided her with her current position.

Even if Ms. Keller at present is not directly implicating KEI, she is employed by KEI, an NGO in DC, under false pretenses. (Also it is debatable if she is at present guilty of intellectual rights violations by simply having her present position, as she has neither the educational background nor intellectual capabilities to hold that position. I can only surmise she is reading my blogs and parroting my work in her schmoozing. Because the Ms. Keller I worked with in 2010, never had an original thought or idea in her life. So either Ms. Keller is impressing you, Prof. Stiglitz and everyone else in the IMF and KEI with my ideas and argumentations.) Ms. Keller does not have the educational background and has made no laboral efforts worthy of a position within KEI.

In good faith I contacted KEI to inform them as to serious ethical issues with one of the Directors in its employ. I was totally ignored. Then, my allegations were never investigated, and you just assumed, I was some "stupid trophy, divorcee" trying to angle her way into a position within KEI. Please be informed, that my suggestion that I be considered for the position as Director of Development, was done so in good faith, and as an opportunity for KEI to "save face" and fulfill their obligations as citizens (and an NGOs) under the *Declaration of Basic Principles of Justice for Victims of Crimes of the Abuses of Power*. As you might appreciate if you read thru my research, communications to govts, blogs and social media campaigns, I am the "New Betty Friedan," and am basically preparing a political framework inline with <u>Riane Eisler</u>. And, as I previously told you my "lineage" is impressive in producing rhetoric for a Revolution, and is why all of the women's rights NGO do not want to employ me. As my first head-hunter told me "too afraid, I'll end up with their job in 6 months, and why their is such an inertia within the women's rights movement.

As I have previously stated Ms. Keller is the typical, social-climbing, back-stabber who gets involves in Expat Wives Clubs to have her picture taken with the Ambassador's wife (in IMFFA case MD's spouse, who at the time was <u>Anne Sinclair</u>, another journalist I have actively been pursuing her to expose the corruption in the courts. I have always denounce Strauss-Kahn's arrest as a political ploy to bring him down, because I know to what extent the courts and press protect the sex offenders in the USA) or promote her husband's career. This is common knowledge in the global mobility industry, and even documented in academic research. These orgs attract social-climbers and back-stabbers. As you can see from the table above, victims of domestic abuse and violence, are silenced and marginalized by the courts, thrown onto the street, where they are then exploited and taken advantage of by anyone, and everyone, with no recourse under the law--as so clearly seen in the case of Ms. Keller as Chair of the IMFFA.

I have informed KEI of Ms. Keller's highly unethical and illegal actions while Chair of the IMFFA, and can only assume it is the ONLY position she has ever held which would even remotely qualify her for Director of Development at KEI, thereby disqualifying her for that position. If there were other merits under which Ms. Keller was considered, I would be interested in knowing them, as they well might be some of my ideas. My story of the past decade (and one which is being repeated by he millions) is why we have so many homeless people, many of which are women and children in the USA. Anyone who encourages unethical, immoral, or illegal behavior that is marginalizing and destroying these people, becomes complicit to the crimes and human rights violations of the original parties. Please see below a passage from my blog <u>The Emperor & His Entourage are "Buck-naked" in "This Town."</u>

Leaders of the IMF, World Bank, and UN are extremely vocal in income equality, gender-equality, economic stability, etc. However, as my case shows, these are just empty words and rhetoric, to hide their slothfulness, ostrich-playing, and toadying. If I had had the "advantages" of any of the people at the IMF, (ie. parents who were not illegally evicted by mortgage scammer banks, along with crime-ring in Louisiana going up to Governor Edwin Edwards, terminating with a "Dukes of Hazzard" shoot-out by local police to force my parents on the run to then be hunted-down by the FBI in the '80 and '90s, while their children struggled to pay their way through colleges—without getting into debt, I might add. Or, a world famous cardiologist, father whose work is belittled and berated by the FDA and pharmaceutical companies, because these organizations are unethical and greedy; see my <u>father's profile</u> and my blog <u>Fractured Fairytale Deb vs. Deb of the Decade</u>), I would be at the head of anyone of the organizations that are looking down their nose at me at present. The only reason I am not considered eligible for any of these positions is that I was not able to buy a PhD or MBA to put after my name. My life story is testament that the present paradigm is not working. Those at the top simply get shoved-off, as everyone grapples to rise to the top. And, unfortunately in "party-hardy" worlds, no one wants a "rollup your sleeve worker" in their midst, so the really hard-workers are the first to be toppled.

A perfect case in point came into my emails yesterday. Please see below the email I received from National Partnerships for Women & Families, in response to my application for Executive Assistant in their organization; the other job I have applied for is Director of Marketing and Communications, but have little hope they will contact me for an interview. I have spent the past 7 years, applying for jobs such as this, but everyone is so afraid "I'll end up with their job in six months" that no one will hire me.

(I believe, people might understand how irate I am, that Anne-Beatrix Keller (whose husband has a sixfigure income at the IMF) is utilizing almost a decade of my research and work (18 hour days with no week-ends or holidays) to collect a handsome pay-check she does not need, and the opportunity to "play dress-up" and rub shoulders with the intellects of <u>This Town</u>, while I fight for my life, the life of my children, and now since this has all become political, for the life of 100s of other million children and women. All because <u>This Town</u> is filled with immoral, unethical people like Anne-Beatrix Keller Semadeni and her husband Werner Keller, an economist at the IMF—along with Mark Plant, the Director of HR at the IMF covering-up the crimes of Ms. Keller, by his ostrichism and toadyism.)

I am well aware that all of my argumentation under human rights and women's rights law is rather complex, and necessitates understanding of more than one area of law. The argumentation I have been using for the past 8 years is synopsised in the book <u>The Human Rights of Women</u>, edited by Rebecca Cook, with the President of Human Rights Watch author of one of the chapters. It took almost a dozen human rights lawyers to come up with the same argumentation as I using only 2 of the UN docs on VAW and good practices, as well as all of the human rights conventions, the Spanish Constitution, civil and penal code and Equality Act (with no PhD or Esq after my name). I believe when lawyers and politicians actually start reading my correspondence, (instead of ignoring me until I disappear, so they can continue to play Ostrich,) they will find that not only is my argumentation as brilliant as that of my grand-father's (he wast the first white man to successfully defend a black man in the South (Alabama) in 1910, but as brilliant as John Dickinson.

I also believe when lawyers and politicians start reading my letters posted on <u>www.warondomesticterrorism.com</u>, they will realize that the grievances I am enumerating to the American and Spanish government, as well as international legal community, are not just grumbling" of some "stupid, greedy trophy housewife, who didn't get as much money out of her poor be-leagued husband in her divorce." Please see my letter to Congress requesting an Oversight Hearing on the State Department and their failure to abide by US federal law, as well as international law <u>Ltr to American</u> <u>Abroad Caucus</u>, and my <u>ltr. to Sec. of State Kerry</u>. with a synopsis of my argumentation to the Spanish govt. provided on my <u>ltr to the Defensor del Pueblo</u>. I defy any lawyer to find loop-holes in my argumentations. Even as a child of 14, I could debate any of the adults I knew "under the table," and the assumption that I do not know what I am doing or talking about, is quite frankly silly. And, if I were a man with the kind of credentials and "blood-line" that I have, all of the "monarchist" in DC would be bowing-n-scraping to me instead of trying to prevent me from competing with them in the job market, as they are doing at present. So I do stand by my statement that "After my CEDAW case is finished, litigation in the USA and Spain will begin with Ms. Keller, the IMF, and IMFFA implicated, as will be KEI, if Ms. Keller is in fact found guilty of intellectual property theft."

Everyone who is "protecting" Ms. Keller from being investigated by the IMF at present, and held accountable for her actions, by their omission of action, will be complicit to the crimes of Ms. Keller under human rights standards. These are not threats. These are facts. It will be up to a court of law to unravel all of the legal liability for the complicity of each individual in the past decade (of my case and millions others.) There is a very simple solution to the rampant corruption in the courts. The ethical lawyers need to start suing the unethical lawyers who have been fleecing the American citizenry of their hard earned money for decades, and redistributing wealth from the criminals back to their victims. And, the unethical judges need to be investigated and held accountable for their crimes.

In the interest of complete disclosure, I wish to inform you, that on top of being inhibited from developing Global Expats in the past decade, because of all of the human rights violations going on, I have been also unable to assist my parents in promoting and marketing their work. in the past decade, my father has been updating his research in the treatment of thrombosis. However, I, nor my siblings, are in the field of medicine, so I must try and find "young" cardiologists interested in his work and clinical studies. My father's pioneer work in thrombosis was always "too expensive" for the American govt. and denigrated by the FDA. The treatment my father developed for deep-vein thrombosis was widely accepted and applauded in the USSR, China, and Europe, but not in the USA. The treatment favored in the USA has been, what my father calls a "high-dosage" aspirin, good for the "lesser" forms of thrombosis, but useless in the treatment of deep-vein thrombosis. Time has shown that my father was right, and the American treatment just is not enough for deep-vein thrombosis. The research my father has been doing in the past decade, help brings the cost down, and now we need clinical trials, etc. My father met with his old colleague and "protege" Denton Cooley, but it looks like Texas is still too much in the pocket of the FDA, for connections there. I am building a profile for my father on Linkedin, but as you can imagine since I have to write all of these letters and emails protesting the violation of my rights, effectively helping my father is too much on my plate at the moment.

So in the past decade, not only have I had my rights violated at every turn, and been prevented in developing my own project and research, I have been prevented in assisting my father. I have also been prevented in assisting my mother in finding a producer for a screen-play she just finished, a "tell all on" President Lincoln. This is my mother's second screen-play. Her first was in the '70s on Frida Kahlo, but was told that while the screen-play was good, "there would be no interest in Hollywood."

Is KEI, the IMF, or even IMFFA responsible for my inability to pursue my "development" as well as assist my parents (in their '90s and do not own or know how to turn on a computer), not directly. But, if Ms. Keller had acted with honesty and integrity in 2010, gone to the IMF told them that they did have a "professional" that had wonderful ideas, offered me a contractual position, with a proper salary instead of getting rid of me and destroying me, then my situation and that of my parents would be very, very different today. As I have repeatedly stated to everyone in the development world "If you would stop disempowering me, then you wouldn't have to worry about empowering me!!! Not rocket science. But, since all the lawyers want to play games with the citizenry, women need to be "empowered"!
