Dear 9th Earl Bathurst,

I am taking the liberty of contacting you in the hopes that you might assist me in assuring that His Royal Highness Prince Charles receives my correspondence to him. I was a room-mate of your sister, Henrietta, at Cobham Hall in '77, and read on the Internet that you are a friend of Prince Charles. It is for this reason I hope you might assist me in my efforts to assure that my correspondence reaches him, instead of ending up in the waste-bin of civil servants at Clarence House.

One of the many historical figures in my family-tree is John Dickinson (Penman of the Revolution), and the only Founding Father of the USA NOT to have signed the *Declaration of Independence*, even though he was the principle author of the *Articles of Confederation*, and the *US Constitution*. The failure of King George III to receive and consider two of the Continental Congress's communications (Petition to the King, 1774 and The Olive Branch Petition, 1775) drafted principally by Dickinson, helped give rise to the American Revolution and the Colonies separation from Britain—causing great blood-shed on both sides in the ensuing war. Not only did Dickinson wish to avoid separation from Britain, but as demonstrated in my lengthy letter to Prince Charles, he had great respect and admiration for the British constitutional monarchy.

The advantage of a constitutional monarchy is that the executive branch is influenced by the monarch's opinion and input, with the monarch retaining "the right to be consulted, the right to encourage, and the right to warn" (W. Bagehot). The advantage of the executive branch whose head enjoys life-time incumbency is that their perspective of the socio-economic challenges facing a nation (or world) are far different than an executive led by term presidencies, whose incumbency is limited to a maximum of 8 or so years. Monarchs see politicians come and go, while presidents are just another name amongst the politicians who come and go—and are easily swept up in the 'dangers of demos worshipping'. The populous support for extremist candidates, as seen in the US elections last year and the rise to power of Donald Trump is a perfect example of that danger, and its consequences. Europe is on the same path as the USA, due to the disempowerment of the monarchs over a century ago; caused by long-standing abuses of power and bad governance of reigning monarchs in centuries prior. Man's quest for a just and sustainable form of government is still very much a 'work-in-progress'—contrary to the many contentions by American politicians, press, and people, lauding the American democratic model as a utopian form of government.

Man is at the cross-roads of humanity, and will destroy itself and this planet, if the paradigm shift world leaders are calling for, but failing to implement, does not occur. Prince Charles is one of the very few people in this world who has the power, and authority to assure that Bretton Woods organizations, namely the International Monetary Fund (IMF), World Bank, and United Nations (UN) start fulfilling their mandates, instead of being the motor behind rising chaos, violence, civil unrest, and economic instability around the world. These organizations were started in the aftermath of WWII in order to prevent another World War. However, as I demonstrate at length in my letter to Prince Charles, these organizations are assuring the demise of our planet, instead of its salvation.

As Sir Winston Churchill so aptly stated, "We must always look forward, but we have to understand our history in order to not repeat the mistakes of the past. I have seen too many instances where people continue to pursue wrong courses of action because they do not take the time to think critically about what has happened in the past."

Never have these words rung truer than in the present state of affairs, as well as in light of the break-up of the European Union and the USA, with civil wars brewing in the US, Spain, and elsewhere. As I explain in my letter to Prince Charles, one of the root causes of the escalation of chaos, violence, and civil unrest is found in the western feminist movement, which began in 1963 with the publication of *The Feminine Mystique* by Betty Friedan. However, in 1981 Friedan published *The Second Stage*, admonishing the feminists for the alpha-dominance feminism that they were promoting and advocating. Unfortunately, Freidan's words fell on deaf ears, and why the fallacy that "placing women in positions of power will assure gender equality within societies" is perpetuated by women in power (ie. Hillary Clinton, Christine Lagarde, Michelet Bachelet, etc.)—as explained in my blog, "Feminism and the Enemy Within." The situation has been further complicated by decades of affirmative action programs which have favored minorities in higher-education and work-force—with the same detrimental effect to the socio-economic functioning of societies.

Not only have women's rights within the home and marriage been eroded by the alpha-dominance feminist movement, but it has caused an escalation of bullying and harassment within the work-place and societies in general. Much of my work, and call for action, challenges the dysfunctional paradigm that the alpha-dominance feminists have been reinforcing and promoting for decades, expanding on the work of Betty Friedan, and implementation of <u>Riane Eisler's</u> research and writings. Additionally, in combating the detrimental effect affirmative action policies have had in the courts, I am challenging the <u>New Jim Crow</u> and the oppressive regime it has helped to create in the USA—which was a 'backlash' to the civil rights movement of the '60s and '70s. As Michelle Alexander, author of <u>The New Jim Crow: Mass</u> <u>Incarceration in the Age of Colorblindness</u>, explains in her book "the discrimination faced by African-American males is [also] prevalent among other minorities and socio-economically disadvantaged populations."

Women and children in family courts are one of the 'socio-economically disadvantaged' groups which are facing the same problems that Afro-American males in American penal systems are facing. This is resulting in an estimated 1 million children in the USA alone, being sexually and physically abused by custodial parents, with courts sanctioning and covering-up that abuse due to criminal negligence of lawyers, judges, and court-personnel. (Please see my reports, "Family Courts in Crisis," "Failure of Family Court to Protect Child Victims of Sexual Abuse," "Domestic Violence in Societies & the Courts," and "Domestic Abuse – A Human Rights Violations the Duty to Protect & Due Diligence.") This is a global problem, with the children affected in the tens of millions, and why I am claiming 'universal jurisdiction' in denouncing and attacking the problems.

The rise to power of Donald Trump and the authoritarian regime he is creating and promoting in the USA SHOULD BE of NO SURPRISE to ANYONE who has been observing the American political arena for the past 50 years. Not only have I been observing the dysfunctional trajectory of the American

government, and society for the past 45 years, but I have also observed these same trends in Europe, England (mid-70s), France, Belgium, and Spain ('88-'97/'03-'08), as well as in Latin America ('97-'03)—as well as the resulting escalating extremism and violence.

I first came to Washington, DC in '81 determined to forge a career in politics and the international arena. However, I quickly became disillusioned with the American political process, and after a brief time working in the financial markets, I moved back to Europe in '88. While I ended up being a 'stay-at-home' mom to my two wonderful children, I never lost my dedication and passion for serving my communities and promoting a better, just world. It is precisely for this reason I came up with the idea for <u>Global Expats</u> in '06, whose mission is to assist expatriated families around the world. Not only did the idea provide me with a way to utilize my extensive knowledge of expatriation and the challenges it presents for all members of the family, but it would permit me to utilize my vast network of people across the globe to effectively challenge the dysfunctional paradigm in which we all live. Since then, networking websites have flooded the Internet, but are nothing more than a place where people can pass out business cards and SELL, SELL, SELL useless products and services.

What I constantly explain to people is that successful networking is not about just 'collecting' contacts, but rather knowing who is in your networks, what they are doing, and connecting those people towards a common goal. It is to this end that I hope you will assure that Prince Charles receives and considers my letter and its content. The world is presently on a very dangerous and violent trajectory, and it is imperative that the few 'good' ladies and gentlemen around the world utilize their power, authority and voice in reversing the self-destructive path mankind, and our planet, is on at present. In the past 10 years, I have been working around the clock in examining the problems of societies and economies. I know what actions need to be taken in the USA, and globally, and hope Prince Charles will listen to and consider my words. If King George III had listened to the words of John Dickinson over two centuries ago (or Queen Elizabeth I had listened to the words of Thomas Wilcox, author of the Puritan Manifesto (1572), over five centuries ago much pain, suffering and blood-shed might have been prevented.

It is time that globalization unite the world in its pursuit of man's salvation, rather than its destruction. I thank you in advance for you time and consideration.
