Dear Mark,

In am contacting you in the interest of Diligence and Transparency—particularly given the elevated level of Lack of Diligence, Integrity, Transparency, and Accountability I encountered within the IMF in my 7-year tenure there (particularly in my 4-year tenure in ICD, and 2-year tenure in IMFFA). Please find attached a copy of my letter to Hali Edison, due to her responsibility for reviewing ‘Women’s issues’ in ICD, as well as copy of my Petition and report “State of the Union during the Demise of Democracy” to [Prince Charles](#). Also, see my letters to my former room-mate at Cobham Hall, [Lady Henrietta Bathurst](#), and her brother, a friend of Prince Charles, [Earl Bathurst](#), requesting that they assure Prince Charles receive and read my correspondence.

In my correspondence to Prince Charles, I explain how the IMF, along with UN and World Bank are the motor behind increasing economic instability, extremism, violence, and chaos in the world. Additionally, I explain how the IMF’s Institute for Capacity Development (ICD) is nothing other than \$330 million ‘window-dressing’ initiative (paid for by taxpayers) designed to covers–up for the lack of integrity, transparency and accountability in finance ministries around the world. Additionally, in my letter I explain that while ICD’s Strategy and Evaluation Division (ICDSE) and Committee for Capacity Building (CCB) SHOULD BE providing the analysis that I provided in my coverage of the IMF/World Bank Spring and Annual Meetings in 2016. But, the ‘important experts’ in the division are too busy schmoozing-and-cruising, promoting their publications, and ‘grappling up the ladder of success’ to care about the damage and chaos their negligence is creating. Also, **I explain how ICD’s Global Partnership division (ICDGP) is complicit to the damage ICD’s training programs are causing as it is this division which is responsible for procuring the funding for the ‘window-dressing’ activities of ICD.**

During my attendance of the CCB and pre-CCB Meetings in Oct. and Nov. ’15, (before being ‘ousted’ from the IMF by ‘queen-for-a-day’, ‘game-playing’ Adrienne Thapa (see my [HuffPost blogs](#) and report “[Workplace Bullying in the IMF](#)”)) I was dismayed to see that the only thing dozens of ‘highly important IMF experts’ were doing (with a slew of support staff, bowing-and-scraping to them, at great expense to taxpayers) was counting the number of training and technical assistance programs delivered to countries around the world. During my attendance of one of the many pre-CCB Meetings, the Director of ICDSE, Robert Powell, asked what everyone thought of the presentation. I responded, “Good. I understood

everything, and I always say if those in your audience who know nothing about your subject matter, understand what you are talking about, you have done a good job.”<sup>1</sup> He condescendingly responded, “it was not meant for ‘YOU’ [the idiot] to understand!”

What the misogynistic, male-supremacist (and ardent Trump supporter) Powell fails to understand is that I am FAR from the ‘idiot’ that all the condescending ‘seat-warmers’ and ‘experts’ in the IMF I have been rubbing shoulders with for 7 years would like to believe—and have tried so desperately to make ME believe with their continual bullying and condescension. I have been the target of this kind of bullying my entire life, precisely because I am NOT an IDIOT, and I ‘see’ through everyone’s BS—and know that they are threatened by my perceptiveness. And, a bunch of IMF ‘egg-heads’ who failed to ‘see’ the ’08 financial collapse coming, as well as the present one, will hardly intimidate me with their ‘games’, bullying tactics, and ostracization. I am VERY interested in examining exactly what the ‘window-dressing’ [ICDSE’s Results Based Management \(RBM\) Project Officer](#) has produced in the past year (at taxpayer’s expense)—a job for which I am HIGHLY and UNIQUELY qualified to fill, but was not even accorded an interview, along with my application for [SPM of ICD](#). Not only does the former SPM of ICD, Gina Paone, need to be investigated for her mis-management of ICD funds and personal travelling (at taxpayer’s expense) while in ICD, but she also needs to be investigated for negligence in her current position in IMF HR as [Division Chief, Talent Acquisition and Operations](#).

In my blogs covering the IMF/World Bank Spring and Annual Meeting, as well as in response to Sean Penn’s Rolling Stone’s article “El Chapo Speaks” and US Elections in ’16, I expose the many issues the IMF, World Bank, and UN (and press) SHOULD BE examining. But, since the ‘experts’ in these organizations are too busy convincing themselves of their own self-worth and importance, they are failing to examine issues from a holistic, intersectional approach, and ‘see’ the ‘Big Picture’. **Jim Yong Kim, Ban-Ki Moon and Antonio Guterres are very vocal in calling for the paradigm shift that I am promoting in my activism work.** Unfortunately, ‘ol guard’ staff in their organizations are not only failing to transform their rhetoric to reality, but they are silencing and oppressing the ONLY one who IS WILLING AND ABLE to do so. Journalist like Thomas Friedman should be writing [‘code red’ articles](#) about those in the IMF, World Bank, and UN who are a danger to democracies around the world by THEIR erratic behavior and incompetence—and in support of the usurpation of the Trump Administration.

As highlighted in my letter to Prince Charles and Earl Bathurst, if King George III had been willing to read and consider the 1<sup>st</sup> Continental Congress’s “Petition to the King,” and John Dickinson’s “Olive Branch Petition,” then the American Revolution, **and much blood-shed, might have been avoided.** Another in my family tree, Thomas Wilcox, sent a similar message and petition to Queen Elizabeth I in 1572, with publication of “Admonitions to Parliament” (aka “Puritan Manifesto”). However, instead of heeding the words of Wilcox, he was sent to the Tower of London and ostracized by British clergy for the rest of his life. Hopefully, after over 500 years of people in my family-tree ([my father](#) and [grand-father](#) included) challenging the predatory and dysfunctional paradigm started by the expansionism of Queen Elizabeth I, and the British Empire; **the British Crown will finally start heeding our words—and reverse the destructive trajectory of the planet and its people. My calls for good governance and equality under the law, are no different than the principles my family has been fighting for and advocating for centuries.**

<sup>1</sup> Einstein put it differently stating, “all physical theories, their mathematical expressions apart, ought to lend themselves to a simple description ‘that even a child could understand them’.” While it was his contemporary Ernest Rutherford who said “it should be possible to explain the laws of physics to a barmaid.”

As I told Holger Floerkemeier in the summer of '15, I know many wealthy and powerful people around the world, and **would have been happy to use my contacts in assisting GP procure funding for its training programs—until I attended the IMF Spring Meetings in '16, that is.** During my attendance of those Meetings, covered in my blog series “[Observation of a CSO Rep at the IMF/World Bank 2016 Meetings](#),” I was dismayed to observe **how IMF policies and training are the motor behind increasing economic instability caused in large part by unbridled greed and corruption in banking systems, financial markets, and business communities. IMF policies which promote full financial inclusion and strengthen government’s tax collection were of particular concern to me, in my analysis of topics discussed during the Meetings, due to the fact that they enable the predatory and greedy banking practices and risky financial investing which dominate markets to funnel more and more savings and earnings of workers into the hands of the 1% elite. Additionally, strengthening tax collection by governments, without first addressing the rampant problem of negligence, corruption, and stupidity of workers in government agencies, only enables and empowers these agencies to exploit and oppress their citizens.**

As everyone in the IMF knows, I have been challenging the corruption and predatory practices of lawyers in court systems for over a decade, documenting with precision the rampant human rights abuses of women and children in family courts. In my quest for justice, and assistance, **I have run the gambit of agencies in judicial, executive, and legislative branches, writing letter after letter explaining their legal obligation to act, what actions are needed, and the legal (penal and civil) consequences of their inaction—see posts on [www.warondomesticterrorism.com](http://www.warondomesticterrorism.com). Unfortunately, NO ONE in these agencies have any idea how to implement their rhetoric with ACTIONS under human rights standards. The quantity of idiots and functionally illiterate people in government agencies, across the board, is of crisis proportions. THIS IS the problem ICD needs to address in their capacity building initiatives, instead of distributing \$330 million ‘window-dressing’ training and technical assistance programs to finance ministries. But, obviously, since ICD (and the IMF) are frantically covering-up for this epidemic problem within THEIR OWN ORGANIZATION, they will hardly be effective, or even try, to address this problem in finance ministries around the world.**

The failure of the FBI to heed warnings regarding the recent school shooter in Florida is TYPICAL of the level of apathy and incompetence found in government agencies. The failure of IMF ‘authorities’ to investigate my allegations of bullying, TWICE, is yet another example. These are hate crimes, and the contention of lawyers that they cannot bring cases to the courts, because there are “no laws” which prohibit bullying is ludicrous. This ‘defense’ demonstrates the extent to which lawyers do not understand why penal and civil codes exist, and much less how to use them. The legal profession is as negligent and corrupt as their ‘brethren’ in the banking and business professions. **‘Training’ (online or in person) is doing NO GOOD, because NO ONE understands what they are reading, or how to implement these theories into REAL ACTION—and no amount of ‘training’ will render them competent or smart. This is why ICD’s \$330 million ‘training’ programs, along with its operating budget, are a total waste of taxpayer’s money—and even counter-productive as they perpetuate the myth that institutions are filled with honorable, competent and well-managed people.**

In '10 a lobbyist for the National Coalition Against Domestic Violence (NCADV) told me that “what was needed” was a new ‘civil rights’ movement. So I “rolled up my sleeves” and produced the rhetoric and political platform needed—which includes challenging the alpha-dominance rhetoric and platforms of the western feminists for the past 50 years. Unfortunately, all the ‘experts’ in the domestic violence industry (in collusion with the alpha-dominance feminists) are more concerned with promoting themselves and their careers and books, than assisting or defending the rights of victims. I have run the gauntlet of the

women's rights, domestic violence, and human rights NGOs (on both sides of the Atlantic) in my quest for allies, and ACTION. However, time and again, all of these 'experts' are showing themselves to be as narcissistic and negligent as the 'experts' in the IMF, World Bank, and UN I have been lobbying on the issues for the past 5 years. The recent firing of top White House personnel, perpetrators of domestic violence, and their 'cover-up' by President Trump, also accused of 'habitual' sexual misconduct, is a perfect example of how, and why male-supremacist networks are colluding to silence and oppress victims—with Trump's threat to 'lock-up' dissenters the REALITY of many, many victims. My ex-husband, in collusion with MY lawyers, on several occasions in '07-'08 in Spain, attempted to 'lock me up, and throw away the key', in efforts to silence me. However, since I have been a target of bullying tactics all of my life, I [saw their 'games' coming from a mile away.](#)

One of the more grievous of the laughable 'women's rights' NGO is Women's Link Worldwide (WLW) which submitted the 2<sup>nd</sup> jurisprudence of violence against women (VAW) as human rights violations, *Gonzalez Carreno vs. Spain* (2014) to international courts (Committee on Elimination of Discrimination Against Women, CEDAW). The defense of the Spanish government in that case was "judicial error, and a failure to exhaust domestic remedies." What I demonstrate in my case against Spain is that "judicial errors" are NOT ERRORS, but rather intentional manipulations of misogynistic, greedy, stupid lawyers. Additionally, I have exhausted 'domestic remedies' (in Spain and the USA) that 'authorities' do not even know exist—and demonstrated that **'domestic remedies' are a MULTI-TRILLION DOLLAR JOKE, with lawyers and civil servants laughing all the way to the bank!** I am offering these 'experts' a wide variety of cases handed to them on a 'golden platter' with evidence and legal argumentation already compiled, but these alpha-dominance feminists are too busy promoting their careers to bother with the plight of women and children in the courts. I am still waiting from an explanation from these 'ladies' as to why they believe [prostitutes in Spain should be protected from police harassment](#), but 'trophy-wives' should not. **Perhaps because prostitutes are remunerated for their services, but wives are not!?!** In the present paradigm everyone and everything is a commodity to be bought, sold and exploited, with defenseless women and children a particular favorite of predators.

Another grievous NGO is Baltasar Garzon's FIBGAR, whose law firm ILOCAD and its 'expert' lawyers are too busy patting themselves on the back to bother to READ my correspondences and argumentation in the case. In addition to WLW, I have handed ILOCAD brilliant cases on a 'golden platter' based on Universal Jurisdiction principles and argumentation. However, all the 'experts' in FIBGAR and ILOCAD are too busy attending conference, giving speeches, and promoting their newest book, to care about the plight of victims. The 'games' being played in Spanish courts (and globally) are the exact same that were played during the fascist regime of Franco (and Hitler), with the same tactics and some of the same actors. Garzon and ILOCAD, by their omission of action, are rendering themselves complicit to the same human rights violations that they are denouncing during the time of Franco, Pinochet, and Bush/Cheney. Nemat (Minouche) Shafik, former Deputy Director of the IMF (and creator of ICD), former Deputy Governor in the Bank of England, and current Director of the London School of Economics 'hit it on the nail' with her speech "[In Experts We Trust?](#)". But, once again demonstrates, **her and ALL the other 'experts', level of 'ostrich-playing' and hypocrisy, with the fiasco of a department she created, along with Sharmini Coorey, in the IMF.** The list of people and organizations in DC that I have contacted in the past 9 years reads like a 'Who's Who' of the DC elite and powerful. However, they are all too busy self-promoting and enriching themselves to bother with the 'general welfare' of society—rending themselves, as well as the government officials they are protecting, ILLEGITIMATE under democratic principles.

The double-tiered system of lawyers in Spain (abogados/procuradores) as well as England (barristers/solicitors) was developed, because as the American Bar Association's Clark Report (1970)

exposed, 70% of lawyers are deficient in preparing evidence, arguing a case, and filing motions—but victims of this criminal negligence have nowhere to turn for justice—because of all the idiot ‘experts’ are ‘asleep at the wheel’. Not only are lawyers systematically covering-up for the negligence of their colleagues (a penal offence), but they are then covering-up their cover-ups with the laughable contention that the legal profession is ‘self-regulating’.

Bar Associations, with sanction rates for lawyers at 2-3%, are also covering-up for rampant negligence and corruption in court systems by their EXTREME negligence in investigating cases—furthering substantiating my claims of ‘crimes against humanity’ by implicated actors. In my own case, and [complaint against 8 lawyers](#), the Bar Association of Madrid (Colegio de Abogados) laughingly claimed that it is “the right of lawyers to violate the rights of their clients under the principle of judicial independence.” (See my reports “[Family Courts in Crisis](#),” “[Failure of Family Court to Protect Child Victims of Sexual Abuse](#),” “[Domestic Violence in Societies & the Courts](#),” and [Domestic Abuse as Human Rights Violations: the Duty to Protect & Due Diligence](#).)

Other grievous NGOs are the NCADV and American Overseas Domestic Violence Crisis Center (AODVCC). I have requested that the NCADV create a chapter for the 7 million American’s living abroad—to no avail. American victims of DV and legal abuse are coming to me with their cases, because AODVCC is nothing but another sham NGO; designed so that its Founder, Paula Lucas can jet-set around the world, schmoozing-and-cruising with Ambassadors and diplomats, while promoting her book, [Harvesting Stone](#). The IMF Family Association (IMFFA), World Bank Family Network (WBFN) and their Domestic Violence coordinator, Elizabeth Legrain, are playing the same game as the Federation of American Women’s Clubs Overseas (FAWCO) in collusion with AODVCC—implicating former Honorary Chair, [Anne Sinclair](#), and present Honorary Chair, [Xavier Giocanti](#), in complicity to the criminal negligence of IMFFA, as well as IMF HR department. The MoU between IMFFA and IMF HR, was signed the day before Anne-Beatrix Keller illegally terminated me (under false pretenses) and transferred legal, and financial, responsibility of wrong-doing by IMFFA board members to IMF (and its employees). Keller has made a FOOL out of the IMF, and all of its employees, but EVERYONE is so busy protecting their pay-checks-and-pensions, to see how they, and their reputations and assets, have been legally exposed, Keller’s manipulations. Financial damages in my case against Spain (naming the US and French governments as accessories) are in the tens of billions of dollars, increasing \$1+ billion each year, with EVERYONE in the development community jumping on the band-wagon of complicity, by their actions, and omission of actions.

At issue, is not only the violation of rights of IMFFA members in cases of domestic abuse, and the failure to protect their members, but also their moral obligation to utilize their power and authority in combating such heinous crimes in courts and societies amongst general populations—noting that globally an approximate 10-20 million children are being viciously beaten, raped, and sex-trafficked by custodial parents (usually fathers). The problems within courts, and the tactics used by unscrupulous lawyers and abusers, are the same worldwide—and one reason I am able to claim Universal Jurisdiction in attacking issues, and building argumentation for international courts. One of the first asinine and condescending contentions of American Consular civil servants in my regard was that my ‘problem’ arose from the fact that my case was in (antiquated) Spain, and not in the (liberal) US, where “women’s and children’s rights are protected.” My response was “Don’t even think of taking me out of the jurisdiction of Spain **you IDIOTS!**” When I began [my examination of the Spanish Constitution, coupled with their penal and civil code, and Equality Act](#), I was astounded at the brilliance of their legal system, and the opportunity it afforded in challenging the corruption within their courts. What further astounded me was the inability of all the ‘EXPERTS’ to understand how to UTILIZE this almost utopian legal system.

The obligation to ACT is admittedly more prevalent within the UN and World Bank as it falls under their purview to a greater extent—as Christine Lagarde highlighted in her response to my question of her in the 2015 Town Hall, following the Annual Meetings in Peru, and which was the following;

*One of the greatest factors “disempowering women” is the failure of governments to protect victims of domestic violence, with victims being revictimized at rates of 70% in courts around the world.*

*Another key problem is that progressive laws in the West are not being effectively implemented – further disempowering women.*

*One of the main issues has been conflict of interest between donors, NGOs, and victim’s rights. Another problem has been the lack of social inclusion of victims, as well as a failure to develop mass constituencies on women’s private rights issues.*

*In order to develop solutions, victims and civil societies need to be empowered.*

*Has the IMF looked at issues women are facing in the courts, how and why they are being disempowered, and what actions the IMF might take to address the issues?*

However, what Lagarde fails to understand, as does David Lipton in his contention that “corruption is not everywhere,” (Spring Meetings ’16), is that the economic consequences for women, their children, and society in general is ENORMOUS. One of the things that most infuriates me so much about Adrienne’s ‘game-playing’ and my wrongful termination in November ’15 was that it prevented me from participating in the IMF ‘Big Data Challenge’, launched by Christine Lagarde in October ’15. In preparing for the contest, I found a young IMF economist, Monique Newiak, willing to help me put together an econometric formula, and presentation showing Lagarde the economic consequences. However, since I was ‘terminated’ in November ’15, Newiak did not want to present the project without me ‘on board’. The information that could be ‘mined’ from ‘Big Data’ on Facebook (and LinkedIn.com) feeds and chats, in addition to group ‘discussions’ in email groups of activists, advocates, and victims (and analyzed by ‘experts’ for trends and problems) would be of ENORMOUS benefit—economically as well as socially. **However, since EVERYONE in the IMF is more concerned with ‘protecting’ the bullying networks in the IMF, than fulfill its mandate—this project too has been put on the ‘back-burner’.**

Maria Jose Carrascosa, a Spanish woman victim of DV and illegally held on contempt of court charges in a New Jersey jail for 8 years is playing the same, [book promotion game](#), and looking to make money for her sham [‘human rights’ law firm](#). Michelle Alexander, author of the [New Jim Crow: Mass Incarceration in the Age of Colorblindness](#), is VERY VOCAL about the problems in court systems, but contends that I “bit off an apple bigger than she is willing to chew” in assisting me to present cases to international courts. Even George and Amal Clooney are playing the [‘ostrich’](#) game, with their recent promise to demonstrate with Florida students in “March of Our Lives” and a donation of \$500,000. [Amal Clooney](#) (before becoming Clooney) along with [Keir Starmer](#) of Doughty Street Chambers were sent my “Family Courts in Crisis newsletters” (along with thousands of human rights lawyers and journalists) in ‘13’-’14. If Clooney and Starmer would help me to bring cases to the international courts, we would not see so many troubled young men ‘losing it’ and going on mass-shooting in schools and communities. The background and profile of these young men is TYPICAL in cases of domestic abuse and neglect, and its violent consequences—as recently highlighted by another mass-shooting in Florida. **An ounce of prevention is worth a pound of cure! And, ‘gun-control’ alone will not stop these violent out-breaks, and murderous rages.**

While misogyny and rampant negligence in the workplace is an age old problem (and why the science of personnel management was invented), entry of women into the work-force in masses, and into positions of power, has only aggravated these problems. Nowhere is this problem more evident than in the US Congress and the bi-partisan bickering and extremism that has increasingly dominated its inner-working since the '80s, caused by the influx of women to positions of 'power'. I began my career on Capitol Hill in '81, and left with dismay over the lack of diligence and conviction to the democratic process by the majority of elected officials as well as their staffers. However, since my return to Washington in '09, and my dealing with those on Capitol Hill, I have been even more disgusted over the degradation of the state of affairs, and the revolving-door of 'cute young things' and 'fresh meat' whose only concern is 'getting their foot in the door' of the 'ladder of success' in 'The Swamp'. As 'New America' states on its website '[About the Congressional Capacity Project](#)', "If you wanted a legislative branch run by K Street lobbyists and 25-year-old staffers, mission accomplished." The quantity of mealy-mouth, spineless kids 'examining' the VERY serious problems facing our country, is CRIMINAL. I have never been a big fan of women as a homogenous group, finding most superficial, self-centered, and frivolous. But, the lack of intelligence, integrity, diligence, and honor of the 'career' women I have been dealing with in the past decade is truly GROTESQUE—**and has brought my disdain for my own sex to new heights!**

While I do not advocate returning women to 'the home', and (barefoot and pregnant status) women need to 'earn' the Right to participate in politics and the public sphere. This same debate was prevalent in the early civil rights movement of Afro-Americans, between Booker T. Washington and W. E. B. Du Bois. Washington advocated for "[a "go slow" approach to avoid a harsh white backlash.](#)" Du Bois, on the other hand, "[felt that African Americans should fight for equal rights and higher opportunities, rather than passively submit to the segregation and discrimination of Washington's Atlanta Compromise.](#)" Unfortunately, Du Bois's ideologies and platform, through the NAACP, was the dominating one, and gave rise to the 'white-backlash' (during the Nixon and Reagan Administrations) that Washington feared.

My grandfather was the first white lawyer to successfully defend a black-man in the 'Deep South' in 1910 (Butler, Alabama), seven years before Harper Lee's father unsuccessfully defended a black-man in Alabama (See my blog series [Harper Lee's Passing: A Legend Dies, But Not Sa Raison d'Etire](#)). And, Congressman Taylor (AL-D) was so impressed with my grand-fathers argumentation of the case, he brought him to Washington to work as a spy for the American government. My grand-father eventually became involved in subversive work for the American government, and 'retired' to marry and raise a family. I often wonder if activist men, like Washington and Du Bois, had taken an interest in my grand-father defense in the 1910 case (instead of a war-mongering government), how the trajectory of the American Civil Rights Movement of the past 100 year might have been VERY, VERY different—sparing MUCH blood-shed and violence in the process. The same bloodshed could have been avoided if King George had heeded the words of Dickinson before the outbreak of the American Revolution.

Fox News commentator and well-known women's rights lawyer, [Wendy Murphy](#), encouraged me at the Battered Mother's Custody Conference (2015) (when I gave my presentation "[Violence Against Women/Domestic Violence as Human Rights Violations](#)") to incite violence amongst the activists, and women. Something I REFUSE to do—leaving that to the Women's March (etc.) people. EVERYONE in the feminist and 'women's rights' movement, from the National Organization of Women (NOW), Feminist Majority Foundation (FMF), Women eNews, the Women's National Democratic Club, Phylliss Chesler, etc., etc. who are advocating for an 'uprising' of women to become the new 'dominators' in society have taken the feminist movement down an extremely dysfunctional and militant path. Betty Friedan (who began the feminist movement with her book, *The Feminist Mystique*, in '63) denounced the violent path of the feminist movement with her book, *The Second Stage*, in '81. However, her call for

sanity and humanity fell on the ‘deaf ears’ of narcissistic alpha-dominance feminists, too busy seeking fame and fortune, to care about the enormous damage they were doing to societies.

I guess time will only tell if I will be more successful than Betty Friedan, or my fore-fathers, in challenging the ‘dominance’ and extremists movements that have ruled our societies for thousands of years. Time will also only tell if I will be able to inject a ‘beta’ movement, where the caring and nurturing women of society are the dominating force, instead of women who want to “make it in a man’s world.” The only thing more damaging to societies than the linear, alpha-male, are the linear-alpha females, and their psychopathic ideologies. While psychopathic men are physically dangerous, and a menace to society; they are no match for the psychopathic women, who can rationalize the most heinous of crimes with the most ridiculous defenses.

While alpha-dominance women have clearly demonstrated that they can hold their own with the psychopathic, alpha-dominance men of the world—and have even surpassed them in their ability to create chaos, disorder, extremism and violence. My question for the men in this world is “**Can you make it in a woman’s world?!**” Because unless men start to stand-up to bullying women, and ‘see through’ and decipher their ‘games’, when these women achieve equality in the number of positions of ‘power’ they hold, they will crush and destroy men worse than men have been crushing and destroying women for centuries. The present attitude that the most intelligent members of society are those who can ‘con and scam’ their way to the top contradicts constitutions, democratic procedure, international law and human rights standards, furthering substantiating my claim that the alpha-dominance movement is guilty of ‘crimes against humanity’. The contention of many, that if I were better at ‘conning and scamming’ people, I would be more successful in my activism work, as well as starting a business, is just further PROOF as to the dysfunctionality of those in power at present.

As every is aware, my ex-husband destroyed his career while Director of the Treasury Department of Banco Ganadero (subsidiary of his employer for 25 years, Spanish multi-national Banco Bilbao Vizcaya Argentaria (BBVA)). But, instead of ‘getting his act together’, and assist me in building what would be a multi-billion dollar company ([Global Expats](#)) he decided to start money-laundering for his brother and cousin’s human-trafficking and prostitution business in Spain. And, while I do not excuse the actions of my ex-husband, past or present; he is NOT the monster many wish to believe. The pressure that traders and bankers are put under, from upper management (raking in the millions and billions of dollars), to consistently produce high-yield propels them to ‘cut-corners’ and get involved in immoral and illegal dealings. Quite a few high-level executives in BBVA are well-aware of my plight, that of my children, and the illegal activity of my ex-husband. However, EVERYONE is just turning a blind-eye to to the situation, and ‘ignoring me’ in the hope I will just ‘disappear’.

Ever since the ‘70s and Mike Milken’s junk-bond scams, banking systems and financial markets have become increasingly dominated by high-risk/high-yield trading (disguised as investing). The true CRIMINALS and MONSTERS are the CEOs and high-level executives of banks and financial institutions who are raking in hundreds of millions of dollars, and turning their companies into Casinos, while piling on enormous pressure and stress on their traders and middle-management to PRODUCE AND PRODUCE. **The other CRIMINALS and MONSTERS are those within finance ministries, central banks, and the IMF who are turning a blind-eye to the CRIMES of these CEOs.** Niall Ferguson’s newest book, [The Square and the Tower: Networks and Power, from the Freemasons to Facebook](#), examine how networks influence society. 

It would behoove IMF staff to ask themselves WHY so many people around the world are angry with them, instead of locking themselves higher and higher in their 'ivory-towers' and heightening security measures to protect themselves from the angry mob. And, will NOT be intimidated by the psychopaths and bullies in 'The Swamp' I am combating. As Martin Luther King once said, "The ultimate measure of a man [or woman] is not where he stands in moments of comfort and convenience, but where he [she] stands at times of challenge and controversy." One of the first lawyers in my divorce told me I had to "appear to be a Señora," but as I told them, "I am not a Señora for the clothes I wear, the car I drive, nor the house in which I live, but who I am, and what I have done with my life. And, if any of these IDIOTS knew how to do their jobs, my 'Lady-ship' would never have been in question!!"

While my coverage is convoluted it examines all of the issues and problems of the world from a holistic, inter-sectional approach, using working papers and reports from the IMF, World Bank and UN. However, there WILL BE a Day of Reckoning, either in this life, or the next, in which they will be held accountable for their actions, and omission of actions.
