Dear Senator Schumer,

I am contacting you regarding the case of your constituent Ms. Andrea Wainer, and the failure of the Singapore judicial system, and Singapore government to comply with national and international law in regards to the custody of her children, Zoey, Aviva, Mylo, Ezra and Ruby. Unfortunately, cases like Ms. Wainer are far from isolated or rare, due to rampant discrimination against women and lack of due process in family courts around the world.

Please find enclosed a letters sent to the American Embassy in Singapore, letters sent to State Department officials in Washington, DC, and letter sent to all of the members of the Americans Abroad Caucus in July 2013—to which I have never received a response. If American Consulates were complying with the national and international law, cases such as Ms. Wainer could be prevented from developing in the first place.


